

BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that more than 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges, economic development, and workforce representatives including labor organizations. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing WDB members for two-year terms.

Brooke Nunn currently serves as the President/CEO of the Temecula Valley Chamber of Commerce. She has been with the Temecula Valley Chamber of Commerce for thirteen years and is a graduate of the Western Association of Chamber Executives (W.A.C.E.) where she earned her Association of Chamber Executives accreditation. During her tenure at the Chamber, she has held a variety of positions, including events director and communications coordinator. Brooke joined the Temecula Chamber team in 2010 where she led planning
