BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The donation to the Jurupa Valley Chamber of Commerce (\$1,500.00) will support the growth and prosperity of Jurupa Valley and its business through commercial, economic, and cultural development.
2. The donation to the Fair Housing Council of Riverside County, Inc. (FHCRC) (\$2,500.00) will support the 2025 Housing Conference to provide necessary information to the community including the foreclosure crisis, recession, and ongoing impact of the pandemic. FHCRC remains dedicated to assisting individuals dealing with foreclosures, homelessness, and high rent costs.
3. The donation to Corona Elks #2045 (\$2,500.00) will help to meet the needs of children with disabilities and provide services to their families at no cost as well as meet the needs of our veteran community to improve their quality of life.
