BACKGROUND:

<u>Summary</u>

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the May 18, 2021 public auction sale. The deed conveying title to the purchasers at the auction was recorded July 28, 2021. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on August 4, 2021 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received two claims for excess proceeds:

- 1. Claim from California Bank & Trust based on an Abstract of Judgment recorded January 4, 2012 as Instrument No. 2012-0002246.
- 2. Claim from William N. Elder Jr, Attorney for California Bank & Trust based on an Abstract of Judgment recorded January 4, 2012 as Instrument No. 2012-0002246.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that California Bank & Trust be awarded excess proceeds in the amount of \$2,220.10. The claim from William N. Elder Jr, Attorney for California Bank & Trust be denied since California Bank & Trust submitted their own claim and has provided documentation to our office that they request the funds be sent directly to them. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.


