**BACKGROUND:**

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports the expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges, economic development, and workforce representatives including labor organizations. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official, is responsible for appointing the WDB members for two-year terms.

Mr. Juan M. De Lara is a Risk Manager at Federated Insurance. Mr. De Lara previously served as Mayor of the City of Coachella, Coachella City Council Member, and City Planning Commissioner. Mr. De Lara has been a strong supporter and active member of the WDB and continues to be involved in the community. He has been instrumental in connecting the WDB with local industry businesses. Mr. De Lara is part of several boards and organizations in the

community. His participation and unique insight in the region that he represents has brought workforce development services to the forefront in the Coachella Valley.

Mr. Juan M. De Lara has expressed interest in continuing to serve on the Riverside County Workforce Development Board as a Private Sector Representative for District 4. If reappointed, he will serve a two-year term commencing July 31, 2024, and expiring July 31, 2026.
