**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. The donation to the County of Riverside – Office of Economic Development (\$500.00) will support the 2024 State of the County for members of the community to engage with county leaders and hear valuable information regarding business and government.
2. The donation to the City of Corona Senior Center (\$4,000.00) will support the Corona Senior Travel Program, “Explore, Dream, Discover”, to allow seniors within the community an opportunity to explore various amenities and landmarks within Southern California.
3. The donation to the Kiwanis Club of Norco Foundation (\$4,000.00) will support scholarships for high school students to assist with tuition, books, computers, and other needs to be successful in their pursuit of their education.
4. The donation to the Freedom Writers Foundation (\$4,000.00) will support the collaboration with the Lake Elsinore Unified School District in their efforts to equip educators with innovative curriculum including offering parent engagement workshops, creating opportunities for the Lake Elsinore community to come together and support students in their educational journeys.
5. The donation to Feeding America Riverside and SB Counties (\$4,000.00) will provide holiday meals to food-insecure individuals, families, and community partners within the Second District.
