BACKGROUND:

Summary 5 1 1

On July 18, 2023 (Minute Order 3.11), in connection with Department of Housing and Community Development (HCD) Round 3 Notice of Funding Availability (NOFA) for Homekey grant funds, the County of Riverside Board of Supervisors approved Resolution No. 2023-222, authorizing Housing and Workforce Solutions (HWS) to submit a joint Homekey application with Abode Communities in the amount of up to \$23,000,000 for the acquisition of the Desert Extended Stay located at 69151 E. Palm Canyon Drive in Cathedral City for the purpose of converting it to 96 units of permanent supportive housing for individuals that are homeless or at risk of homelessness, and impacted by COVID-19 ("Project" or "Desert Marigold"). HCD conditionally awarded Abode Communities and the County of Riverside \$21,724,000 in Homekey funds through a conditional award letter dated May 1, 2024.

The County of Riverside Board of Supervisors, on July 18, 2023 (Minute Order 3.11) as part of Resolution No. 2023-222, also approved matching funds in the amount of \$5,000,000 in Permanent Local Housing Allocation (PLHA) Funds to increase the competitive tie breaker score of the Homekey application, subject to the satisfaction of certain conditions contained therein.

SUBMITTAL TO THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE, STATE OF CALIFORNIA

Abode Communities has established Desert Marigold, L.P., a California limited partnership, for the ownership of the Project. Additionally, Desert Marigold GP, LLC, a California limited liability company, has been formed to serve as the sole general partner of the limited partnership.

On June 11, 2024 (Minute Order 3.24), the Board of Supervisors approved Resolution No. 2024-118, after the County received a conditional award letter from HCD. One of the conditions stipulated the addition of Desert Marigold, L.P. as the owner of the Project and inclusion in the Standard Agreement for the Homekey funds. To fulfill the requirement, HCD mandated that Abode Communities and the County of Riverside, as Co-Applicants, submit resolutions from their respective Boards authorizing the action. HCD has requested Resolution No. 2024-118 be amended to authorize Desert Marigold GP, LLC as a Co-Contractor to enter into the Standard Agreement for the Homekey funds.

With this award, the County will have secured a total of five Homekey awards from the State, amounting to \$62,925,998. This funding has enabled the development of 384 permanent supportive housing units, enhancing the County's housing stock to help address homelessness in Riverside County. The County partnered with Abode Communities on another Homekey application in the City of Corona to acquire the Ayres Hotel, resulting in the creation of 52 supportive housing units. This Project has significantly improved the surrounding community's ability to address homelessness, and the County is building on that successful relationship with this proposed project in Cathedral City.

Staff is requesting the rescission of the previously adopted Resolution No. 2024-118, approval of the attached resolution authorizing the execution of the Standard Agreement for Homekey funds for the Project, allowing the limited partnership to hold title of the Project and authorizing both the limited partnership and Desert Marigold GP, LLC as Co-Contractors. County Counsel has reviewed the attached Resolution No. 2024-226 and approved as to form.

Impact on Residents and Businesses

The Project will create 96 units of permanent supportive housing to address lack of housing available to our homeless population in the Coachella Valley.

Additional Fiscal Information

No impact upon the County's General Fund, the proposed project was funded with State Homekey Program grant funds and the County's allocation of PLHA funds.

WHEREAS, the Department of Housing and Community Development ("Department") has issued a Notice of Funding Availability ("NOFA"), dated March 29, 2023 for the Homekey Program ("Homekey" or "Homekey Program") and the Department has issued the NOFA for Homekey grant funds pursuant to Health and Safety Code section 50675.1.3 (Assembly Bill No. 104 (2021-2022 Reg. Sess.), § 21.);

WHEREAS, the County of Riverside ("Co-Applicant") jointly applied for Homekey grant funds with Abode Communities, a California nonprofit public benefit corporation (the "Corporation"). Therefore, Co-Applicant is joining Corporation in the submittal of an application for Homekey funds ("Application") to the Department for review and consideration;

WHEREAS, the Corporation acts as the sole member of Desert Marigold GP, LLC, a California limited liability company (the "LLC") and the LLC acts as the sole general partner of Desert Marigold, L.P., a California limited partnership (the "Partnership");

WHEREAS, the Corporation, on its own behalf and as the sole member of the LLC, which LLC is acting in its own capacity and as the general partner of the Partnership (collectively, its "Capacities") desires to jointly apply for Homekey grant funds with the County of Riverside ("Department", and collectively, with the Corporation, the LLC and the Partnership, the "Co-Applicants"). Therefore, Co-Applicants are joining in the submittal of an application for Homekey funds ("Application") to the Department for review and consideration;

WHEREAS, the Department awarded the County and Abode Communities \$21,724,000 in Homekey funds as evidenced by Standard Agreement Contract Number 23-HK-18299 dated on or about May 1, 2024;

WHEREAS, Applicant will use Homekey funds to acquire the Desert Extended Stay Hotel located at 69151 E. Palm Canyon Drive in the City of Cathedral City for the purpose of providing 97 units of permanent supportive housing for qualified individuals and families who are homeless or at risk of homelessness and impacted by COVID-19 ("Property");

WHEREAS, the Department is authorized to administer Homekey pursuant to the Multifamily Housing Program (Chapter 6.7 (commencing with Section 50675) of Part 2 of Division 31 of the Health and Safety Code). Homekey funding allocations are subject to the terms and conditions of the NOFA, the Application, the Department-approved STD 213, Standard Agreement ("Standard Agreement"), and all other legal requirements of the Homekey Program;

WHEREAS, Abode Communities at the time of the acquisition of the Property formed Desert Marigold, L.P., a California limited partnership for purposes of ownership of the Property; and

WHEREAS, Abode Communities and County of Riverside request that the Department amend the Standard Agreement (Contract Number 23-HK-18299) to add Desert Marigold, L.P. and Desert Marigold GP, LLC as Co-Contractors.

NOW THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED by the Board of Supervisors of the County of Riverside, State of California, ("Board") in regular session assembled on or about October 22, 2024, in the meeting room of the Board located on the 1st floor of the County Administrative Center, 4080 Lemon Street, Riverside, California, and based upon the evidence and testimony presented on the matter, both written and oral, including the Administrative Record as it relates to the Homekey Application, as follows:

- The County hereby agrees to add Desert Marigold, L.P., a California limited partnership, and Desert Marigold GP, LLC., a California limited liability corporation, as Co-Contractors in the Standard Agreement (Contract Number 23-HK-18299).
- 2. Co-Applicant is hereby authorized to execute the Standard Agreement Amendment (Contract Number 23-HK-18299) between the County of Riverside, Abode Communities, Desert Marigold, L.P., Desert Marigold GP, LLC, and the Department of Housing and Community Development for the Homekey grant funds in a total amount of \$21,724,000. That amount includes \$21,125,000 for capital expenditures (as allowed under Health and Safety Code, § 50675.1.1, subd. (a)(1)-(6)) and \$599,000 for relocation costs (as allowed under Health and Saf. Code, § 50675.1.1, subd. (a)(6)).
- 3. Co-Applicant is hereby authorized and directed to ensure that any funds awarded for capital expenditures are spent within eight (8) months of the date of award, and that any funds awarded for capitalized operating subsidies are spent by June 30, 2026.
- 4. If the Application is approved, Co-Applicant is hereby authorized and directed to enter into, execute, and deliver a Standard Agreement in a total amount not to exceed \$21,724,000, any and all other documents required or deemed necessary or appropriate to secure the Homekey funds from the Department and to participate in the Homekey Program, and all amendments thereto (collectively, the "Homekey Documents").
- 5. Co-Applicant acknowledges and agrees that it shall be subject to the terms and conditions specified in the Standard Agreement, the Standard Agreement Amendment, and that the NOFA and Application will be incorporated in the Standard Agreement by reference and made a part thereof.
