BACKGROUND:

Summary

By Minute Order 13.3 on July 9, 2024, the County of Riverside Board of Supervisors authorized the Clerk of the Board to advertise for the Lawler Lodge ADA & Cabin Updates Project on August 12th and August 19th, 2024.

Lawler Lodge was originally built in 1919 in the Idyllwild Mountains consisting of a large lodge building and several ancillary cabins. The lodge is located at the bottom of a hill and therefore not easily accessed. The project will restore two of the ancillary cabins located above the lodge,

making them available for use and making one adjacent to the parking lot an ADA-accessible short-term lodging unit for the site.

During the advertisement period, two addendums were issued to all registered plan holders as a supplement to the plans and specifications. Both addendums are attached as Addendum No. 1 and Addendum No. 2.

The project includes the following schedules for work:

Base Bid Schedule: Lawler Lodge ADA and Cabin Updates

Alternate Bid Schedule 1: Builders Risk Insurance

RivCoParks accepts the bid prices submitted by CALTEC Corp. (Contractor) for the Base Bid Schedule and Alternate Bid Schedule 1. The Contractor is qualified to perform the work as outlined in the bid, has executed the contract, and has provided bonds and insurance documents.

Impact on Residents and Businesses

Due to the scope of the Project, RivCoParks will require a full closure of Lawler Lodge until the completion of the Project. The work is scheduled to begin in March 2025 due to the winter snowy conditions and is expected to be completed by the end of 2025. The Project will initially and temporarily impact Citizens by removing access to the site, however, the Project will enhance the quality of life for Riverside County residents by maintaining access to clean and safe outdoor recreational activities.

Additional Fiscal Information

American Rescue Plan Act (ARPA) funds in the amount of \$1,500,000 were allocated to this project on May 23, 2023, by Minute Order 13.1. This project is partially funded by the Fourth District's ARPA allocation. RivCoParks is requesting an additional allocation of \$674,097 from the Fourth District's Second ARPA allocation to cover the gap in the overall Project budget, and a reallocation of \$635,487 excess ARPA funds on the Lake Cahuilla Veterans Regional Park Modernization Project approved on August 27, 2024 by Minute Order 13.5.

On October 8, 2019, per minute order 13.1, District Board of Directors authorized the acceptance of grant funds from the State of California, Department of Parks and Recreation, Office of Grants and Local Services (State Parks) for its Per Capita Grant Program. Funds are available for local park rehabilitation, creation, and improvements grants to local governments on a per capita basis. Per Capita Grant funding in the amount of \$351,442 has been allocated to this project.

The overall cost for the Lawler Lodge ADA & Cabin Updates Project is \$3,161,026 which includes the PS&E (8%), Administrative (4%), Construction (71%), Allowance (9%), Furniture and Equipment (6%), and Inspectors (1%). Additional details on the Project budget can be found in the attached Project Budget Attachment.

Contract History and Price Reasonableness

RivCoParks received four bids on Wednesday, September 4, 2024. The basis of award base bids ranged from \$2,222,000 to \$2,684,000. CALTEC Corp. was selected as the contractor with the lowest responsive and responsible base bid at \$2,222,000 which is approximately \$497,000 (29%) above the engineer's cost estimate. CALTEC Corp. also submitted a bid for Alternate Schedule 1 for \$10,000 which was accepted. The contract as presented for award also includes an Owner Controlled Allowance of \$300,000. Collectively, the Base Bid (\$2,222,000), Alternate Schedule 1 (\$10,000), and the Owner Controlled Allowance (\$300,000) result in a total contract award of \$2,532,000.

AGREEMENT

This agreement is made and entered into on the date of final signature hereto, by and between the Riverside County Regional Park and Open-Space District ("District") and Caltec Corp. ("Contractor") ("Agreement"). The District and the Contractor agree as follows:

The Work: Contractor shall furnish all tools, equipment, apparatus, facilities, labor, and material necessary to perform and complete in a good and workmanlike manner, the work of the following project:

Lawler Lodge ADA and Cabin Updates ("Project" or "Contract" or "Work")

The Work shall be performed and completed as required in the Contract Documents as defined in the General Conditions including, without limitation, the Drawings and Specifications, under the direction and supervision of, and subject to, the approval of the District or its authorized representative.

Classification of Contractor's License: Contractor hereby acknowledges that it currently holds valid Type A,B Contractor's license(s) issued by the State of California, Contractor's State Licensing Board, in accordance with division 3, chapter 9, of the Business and Professions Code and in the classification called for in the Contract Documents.

Time for Completion: It is hereby understood and agreed that the Contractor shall complete the Work by or before Monday, December 22, 2025.


The District shall not approve an early completion schedule by Contractor. A schedule showing the Work completed in less than the Contract Time indicated in the Contract, shall be considered to have Project Float.

Contract Price: In consideration of the foregoing covenants, promises, and agreements, Contractor offers, in the amounts stated below, to perform the Work according to the Contract Documents. District covenants, promises, and agrees that it will pay and cause to be paid to Contractor in full, and as the Contract Price the following amount(s):



THE ABOVE ALLOWANCES, IF ANY, ARE WITHIN THE CONTRACT PRICE ONLY TO THE EXTENT CONTRACTOR HAS BEEN AUTHORIZED IN WRITING TO PERFORM WORK ENCOMPASSED BY THE ALLOWANCE DESCRIPTION, HAS PERFORMED THE WORK AND HAS APPROPRIATELY INVOICED FOR THAT WORK, AND DISTRICT HAS APPROVED CONTRACTOR'S INVOICE. USE OF ALLOWANCE(S) SHALL FOLLOW THE PROCESS AND THE IDENTICAL STRUCTURE AS A CHANGE ORDER. THE UNUSED PORTION OF ALLOWANCE(S) SHALL BE RETAINED BY THE DISTRICT AND MAY BE CLOSED BY A UNILATERAL CHANGE ORDER.

The Base Contract Price and authorized use of allowances shall be paid in lawful money of the United States pursuant to the payment provisions in the General Conditions.

The Contract Documents: The complete Contract consists of all Contract Documents as defined in the General Conditions and incorporated herein by this reference. All obligations of the District and Contractor are fully set forth and described in the Contract Documents. The Contract Documents are intended to cooperate so that Work called for in one and not mentioned in the other or vice versa is to be performed the same as if mentioned in all Contract Documents.

Interpretation of Contract Documents/Order of Precedence: Questions concerning the intent, precedence, or meaning of the Contract Documents, including the Drawings or Specifications, shall be submitted to the District for interpretation. Inconsistencies in the Contract Documents shall be resolved by giving precedence in the following order:

- (i) District-approved modifications (e.g., Change Orders, Force Account Directives, etc.), beginning with the most recent (if any);
- (ii) Agreement:
- (iii) Special Conditions (if any);
- (iv) Supplemental Conditions (if any);
- (v) General Conditions:
- (vi) Remaining Division 0 documents (Documents beginning with "00");
- (vii) Division 1 Documents (Documents beginning with "01"):
- (viii) Division 2 through Division 49 documents (Technical Specifications);
- (ix) Figured dimensions;
- (x) Large-scale drawings:
- (xi) Small-scale drawings.

In case of conflict, the greater quantity and/or higher standard of workmanship shall apply unless the District expressly in writing (e.g., via a Change Order) accepts a lesser quantity or lower quality of workmanship and the Contract Price is adjusted accordingly. The decision of the District in the matter shall be final.

Integration / Modification. The Contract Documents and any documents specifically incorporated by reference are completely integrated as the complete and exclusive statement of the terms of the Agreement. This Agreement supersedes all previous contracts, agreements, and / or communications, both oral and written, and constitutes the entire understanding of the District and Contractor. No extrinsic evidence whatsoever shall be admissible or used to explain or supplement the terms of the Contract, Contract Documents, or any items

incorporated by reference. No changes, amendments or alterations shall be effective unless in writing, signed by both Parties, and unless provided otherwise by the Contract Documents.

Completion-Extension of Time: If Contractor fails to complete the Work within the Contract Time, due allowance being made for the contingencies provided for herein, Contractor shall become liable to District for all loss and damage that District may suffer on account thereof. Contractor shall coordinate its Work with the work of all other contractors. The District shall not be liable for delays resulting from Contractor's failure to coordinate its Work with other contractors in a manner that allows for timely completion of Contractor's Work. Contractor shall be liable for delays to other contractors caused by Contractor's failure to coordinate its Work with the work of other contractors.

Liquidated Damages: Time is of the essence for all Work to be performed. It is hereby understood and agreed that it is and will be difficult and/or impossible to ascertain and determine the actual damage that District will sustain in the event of and by reason of Contractor's delay; therefore, pursuant to Government Code section 53069.85 and Public Contract Code section 7203, Contractor shall forfeit and pay to District the sums as indicated in the Special Conditions ("**Liquidated Damages**").

Use of Unit Prices and Bid Alternates: The District may, at its sole discretion, increase or decrease the Contract Price by unit prices or alternates contained in Contractor's original bid. If the Bid for the Work included proposal(s) for Alternate Bid Item(s), during Contractor's performance of the Work, the District may elect to add any such Alternate Bid Item(s) if the item did not form a basis for award of the Agreement or delete any such Alternate Bid Item(s) if that item formed a basis for award of the Agreement. If the District elects to add or delete an Alternate Bid Item(s) pursuant to the foregoing, the cost or credit for that Alternate Bid Item(s) shall be as set forth in the Contractor's Bid, at the District's discretion. If any Alternate Bid Item is added or deleted from the Work pursuant to the foregoing, the Contract Time shall be adjusted by the number of days allocated for the added or deleted Alternate Bid Item in the Contract Documents; if days are not allocated for any Alternate Bid Item added or deleted pursuant to the foregoing, the Contract Time shall be equitably adjusted.

Insurance and Bonds: Contractor shall provide all required certificates of insurance, and payment and performance bonds.

Performance of Work: If Contractor fails to perform the Work properly or fails to perform any provisions of this Contract, the District, may, pursuant to the General Conditions and without prejudice to any other remedy it may have, cure the deficiencies and deduct the cost thereof from the payment then or thereafter due Contractor.

COVID-19. Contractor is responsible for complying with all applicable and existing federal, state, and/or local statutes, orders, rules, regulations, ordinances, and/or directives relating to construction site safety in connection with COVID-19, and/or any similar virus or derivative strain. Contractor shall ensure it has supervisor employees onsite that are trained and knowledgeable of all of these requirements to ensure full compliance on Project Site(s).

Authority of District, Architect, Project Inspector, and County Permitting Entity:
Contractor hereby acknowledges that the District, Architect(s), the Project Inspector(s), and the County Permitting Entity as applicable to this Project have authority to approve and/or stop Work if Contractor's Work does not comply with the requirements of the Contract Documents, Title 24 of the California Code of Regulations, and all applicable laws. Contractor shall be liable for any delay caused by its non-compliant Work.

Assignment of Contract: Neither the Contract, nor any part thereof, nor any moneys due or to become due thereunder, may be assigned by Contractor without the written approval of District,

nor without the written consent of the Surety on Contractor's Performance Bond (the "Surety"). unless the Surety has waived in writing its right to notice of assignment.

Payment of Prevailing Wages: Contractor and all Subcontractors under Contractor shall pay all workers on Work performed pursuant to this Contract not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seg, of the California Labor Code.

Contractor & Subcontractor Registration: Contractor shall comply with the registration and compliance monitoring provisions of Labor Code section 1771.4, including complying with any applicable enforcement by the Department of Industrial Relations.

Authority of Contractor's Representatives: Contractor hereby certifies that the person who executes this Agreement has the authority and power to legally bind the Contractor. Contractor also certifies that the person(s) it employees on the Project at or above the level of project superintendent, each have the authority to legally bind the Contractor.

Severability: If any term, covenant, condition, or provision of the Contract Documents is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the provisions in the Contract Documents shall remain in full force and effect and shall in no way be affected, impaired, or invalidated thereby.

The following is issued to supplement or revise the Contract Documents. The revisions to the documents are described below. Unless specifically changed by this addendum, the remainder of the drawings, documents, and specifications shall remain in effect as originally issued. It is the obligation of the contractor to make subcontractors aware of this addendum.

General Note: Any dates and times originally published by the Riverside County Board of Supervisors are subject to change. Changes are reflected in the bid documents and any addenda that may be issued thereto.

GENERAL & BID DOCUMENTS:

- 1. Note: Tree trimming around existing and proposed structures shall be the responsibility of the District. District shall trim back 15' to provide adequate clearance prior to construction.
- Replace in its entirety the Project Manual cover page. The cover page inadvertently referenced another project, but the manual is correct for this project.
- 3. Instructions to Bidders, Section 2 Project Defined, and shall be appended to include the following additional base bid scope:
 - "Additional Parking Area: Provide an expanded parking area to include pavement in the space adjacent to the existing trash storage building. See Sketch #1 Additional Parking Area. Demolish the rock wall and remove dirt as needed for final work to match grade of existing pavement. Provide striping for four standard (non-ADA) parking stalls with wheel stops. Reference specification section 32 12 16 Pavement, Section 32 17 23 Pavement Markings, and Sheet A 1.0 Keynote 47 New Concrete Tire Stop."
- 4. Clean dirt, as inspected and approved in advance by District Project Manager, and free of construction debris including but not limited to: hazardous waste, asphalt, concrete, metal, trash and other detritus shall be stockpiled on site in two locations: Open area east of Scout Cabin or in the picnic area just below the south end of the parking lot. Care

must be taken to not overwhelm one area over the other. See new sketch titled "Sketch #2: Site Laydown Area" referenced and incorporated herewith. Note that the stockpile must be appropriately piled and protected as per the details in the Sketch.

5. Special Conditions section 1. Federal Funding paragraph A. Project Description is hereby replaced in its entirety as follows:

"The information provided here is a summary only. All bidders must thoroughly review the Plans and Specifications and the other Contract Documents for a full understanding of the scope of the Work of the Project.

- (a) Scope.
- (1) The project generally consists of: Demolish and rebuild 2 cabins on existing footprints, new septic system and parking lot renovation.

This project also includes the reroofing of Lawler Lodge. See Specifications for scope. This portion of work must be taken off separately for purposes of providing it in its own section subtotaled on the Schedule of Values postaward."

6. Deferred approvals apply to this project. See Plans page A0.0 General notes #6 & #7.

Special Conditions paragraph 5 is hereby to be marked as YES "REQUIRES THE CONTRACTOR TO OBTAIN DEFERRED APPROVALS.", and is appended to include the following paragraphs:

"The following item(s) will require acceptable submittals to be taken through permitting:

- a) Fire Sprinklers
- b) Fire Hydrant with storage tank

1.

Deferred Approvals – Permitting Process: The timelines for the submission of the Submittal of the pre-designed restroom building shall have a special process. Initiation of the Submittal shall follow the timeline in the General Conditions. Once the Submittal has been accepted as complete, the architect's review will proceed. If there are corrections or comments, the Contractor shall have 5 working days to respond. The response shall not be deemed compliant with this timeline unless every item is properly addressed.

Once a complete and acceptable Submittal for an item requiring Deferred Approval is in place the District shall move the Submittal into permitting. The permitting process is with an entity internal to the Parks system and typically takes 2-3 weeks for an initial response. If comments are made, the Contractor shall have 5 working days to respond. The response shall not be deemed compliant with this timeline unless every item is properly addressed.

The permitting agent typically responds to replies to comments in 2 weeks or less. Every effort by the District and the Architect shall be made to expedite permitting. Time is of the essence for all parties. If the Contractor finds that an extension to response time is necessary, a written request shall be presented to the District's Project Manager for consideration at least 2 working days before the expiration of response days and must include detailed reasons for the extension."

- 7. Specification 06-16-43 Gypsum Sheathing is added in its entirety as well as a courtesy revised Table of Contents.
- 8. Specification 32-12-16 Asphalt Paving and Crushed Aggregate Base, Section 2.1 paragraph (B) is replaced in its entirety as follows, "Asphalt shall be PG 64-16.".





1.2 PROJECT REQUIREMENTS

- A. Design Requirements: Provide systems capable of resisting deflection.

Submittal Required: Submittal for the NFPA 1142 Fire Storage Tank and shall comply with the following specifications using RivCo Technical Policy 23-001 as reference:

- I) Contractor shall provide storage tank with base per plans below. Storage Tank Details:
 - a. Storage tank volume shall be 5,000 gallons. Tank shall be Pioneer Water tank model XL01 R3 or approved equal.
 - b. Tank construction material shall be 12-gauge steel.
 - c. 4" outlet plumbed to remote hydrant (with location identified on plans facing apparatus access)
 - d. External water level indicator: Tank Products Inc. Model 1200 or 1215 full travel liquid level indicator or approved equal
 - e. Auto re-fill device: SJE-RHOMBUS float switch model 15PMWPSWE or approved equal
 - f. 4" x 6" Aluminum Data nameplate rivet affixed in a location that does not damage the tank/piping or impede use.


FIGURE 1

II) Trench & Piping Details:

- a. Pipe size shall be 4 inches diameter from the storage tank to the hydrant.
- b. Steel pipe shall be minimum schedule 40 and fittings schedule 80.
- c. Steel pipe and joints shall be coated and wrapped with standard insulating foam and wrapped with waterproof tape to protect from corrosion.
- d. Depth of cover and embedment shall follow drawing detail below min. 48". Depth shall be reached despite roots. Should a boulder or similar underground conditions be discovered, the District Project Manager must be consulted. No blasting is required. Should the Project Manager allow a depth less than 48" in this condition piping above 48" shall be wrapped with standard insulating foam and wrapped with waterproof tape prior to covering.
- e. This site is subject to freezing. Where fire service piping passes above 48" and to the connection point, it shall be protected by a reliable means to maintain the temperature of the water in the piping between 40-120 degrees Fahrenheit.
- f. Appropriate thrust blocks or mechanical restraints shall be provided for stability of the underground piping between the tank and the draft hydrant at each elbow.
- g. All utility backfill shall meet the requirements for compaction appropriate to the type of paving/finish. Compaction of soils in natural areas shall be appropriately hand-tamped. All backfill may use onsite spoils.
- h. Any on-site soils used for backfilling utility trenches shall be free of organic matter and deleterious substances.
- i. Pipe bedding shall be sand or consist of clean, non-expansive granular soils with a sand equivalent (SE) of 30 or greater.






