**BACKGROUND:**

**Summary**

The Inmate Welfare Fund (IWF) is established and operates in accordance with section 4025 of the California Penal Code. The Sheriff has established an IWF Committee to assist with oversight of IWF operations in conjunction with Sheriff's Inmate Training and Education Bureau (SITE-B) to develop and approve inmate program expenditures.

The Sheriff maintains executive oversight of the IWF Committee and has sole authority to accept, reject, or amend decisions made by the Committee.

The IWF Expenditures Report for FY 2024 ending June 30th, 2024, is being submitted to the Board of Supervisors pursuant to section 4025(e) of the California Penal Code. Included in the report are the expenditures which occurred during the fiscal year.

**Impact on Residents and Businesses**

The IWF supports inmate services, such as education and vocational programs, rehabilitation programs, and other programs designed to reduce recidivism.
