**BACKGROUND:**

**Summary**

These overpayments are as described in R&T Code Section 5097.2 (c), which allows a county tax collector or county auditor to refund property taxes paid to the county if “the amount paid exceeds the amount due on the property as the result of corrections to the roll or cancellations after those taxes were paid”. If a claim for refund is not timely filed by the claimant, R&T Code Section 5102 authorizes the Board of Supervisors to transfer the overpayments to the general fund.

Effective July 1, 2024, the Auditor-Controller’s office has assumed responsibility previously managed by the Treasurer-Tax Collector’s office. During this transition period, both offices shared responsibility. Updates across various websites, as well as the development of internal programs for the Auditor-Controller were required to necessitate the change in staffing updates.

In addition to the minimum requirements by law, a policy has been voluntarily adopted which allows the claimant an additional 90 days to file a claim. As part of the policy, the following actions were taken to locate the rightful party of the unclaimed property tax overpayments, which were above and beyond what we were required to do by law.

- Advertised in the newspapers for two consecutive weeks (Desert Sun, Palo Verde Valley Times and The Press Enterprise) referring potential claimants to the TTC’s website.
- Placed links on the County’s main website, the Property Tax Portal as well as the TTC’s website and ACO’s website on May 1, 2024 through August 1, 2024.
- Contacted by phone each of the governmental entities that are on the unclaimed roll change refund list and directed them to the ACO’s website.
- Used Accurint (people finder) to locate possible new addresses for each of the potential claimants and mailed a letter referring them to the ACO’s website.

\*The TTC and ACO websites included a detailed listing of all property tax unclaimed refunds that have met the requirements of R&T Code Section 5102.

- Began with 1,343 unclaimed property tax overpayments totaling \$1,610,731.08.
- During the additional 90-day filing period we received 45 claims totaling \$80,289.92.
- Determined 20 claims were denied for various reasons in the amount of \$19,989.60.

These claims were for the following fiscal years:

- o 2014-2015: \$3,689.86
  - o 2015-2016: \$737.90
  - o 2017-2018: \$3,118.61
  - o 2018-2019: \$10,626.34
  - o 2019-2020: \$1,816.89
  - o Total: \$19,989.60
- We are requesting to transfer 1,298 property tax unclaimed refunds totaling \$1,530,441.16; \$1,480,440.47 to the General Fund and \$50,000.69 to the Auditor-Controller's and Treasurer-Tax Collector's budget for reimbursement of costs incurred in the process.

**Impact on Residents and Businesses**

Claimants had an additional 90 days to file a claim per a policy voluntarily adopted by the Treasurer-Tax Collector.
