

BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports the expansion and development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges, economic development and workforce representatives including labor organizations. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairmen who serves as the Chief Local Elected Official, is responsible for appointing the WDB members for two-year terms.

Mr. Jamil Dada, Vice President of Provident Bank and highly distinguished community leader, is a long-time member of the WDB and has served several times as Chairperson, currently serving as the Vice Chair. His two biggest priorities are our nation's workforce and

its military, which frequently takes him to Sacramento and Washington D.C. where he is routinely at the table with key Congressional Leaders and with the Department of Labor and Administration Officials.

Mr. Dada is a Gubernatorial Appointee serving his third straight year for the Governor of California. Mr. Dada has been a member of the California Workforce Development Board since 2004 where he served as chairman for two years. He is also a board member of the National Association of Workforce Boards in Washington D.C, where he served as chairman for two years.

Mr. Dada also serves on several boards and commissions related to the former March Air Reserve Base, or March Field. His service includes Chairman of the March Field Foundation, President of the March Field Air Museum and Chairman of the Greater Riverside Chamber of Commerce's Military Affairs Council. He is a member of Air Mobility Command's Civic Leader Advisory Board and the 452nd Air Mobility Wing's Honorary Wing Commander. Additionally, he is a Past Chairman of the Moreno Valley Chamber of Commerce and is a longtime member and past President of his Rotary Club.

In addition to supporting our military, Mr. Dada is also very passionate about Base joint use efforts, collaborating to bring good jobs to former Base surplus land. In that respects he has worked very closely with the base re-use agency, the March Joint Powers Authority, since its inception in 1994.

In 2007, the California Chamber of Commerce in Sacramento awarded him their "Small Business Advocate of the Year". In 1997, Mr. Dada was awarded the Citizen of the Year award for Moreno Valley and most recently in March 2020, was awarded Citizen of the Year award for the City of Riverside.

Mr. Dada is very involved with the Riverside Community College District, where he serves in leadership roles in several committees. In May 2014, the Riverside County Board of Supervisors unanimously renamed the County's Annual Youth Award Ceremony the "Jamil Dada Character Excellence Youth Award" Ceremony.

Mr. Dada's extensive involvement and connections within the local, statewide and national workforce community have brought recognition to Riverside County and the WDB. His active involvement with Governor Newsom's initiatives has brought business leaders, educators, stakeholders, and other organizations together to address employment and training needs of the community. With his guidance, the County and WDB have consistently met local, regional, and state plan goals.
