BACKGROUND:

Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports the expansion and development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges, economic development and workforce representatives including labor organizations. This ensures that federal funds for workforce development activities are expended on activities that meet the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official, is responsible for appointing the WDB members for two-year terms.

Mr. Robert Spiegel has served as the President/CEO for the Corona Chamber of Commerce for over 23 years and previously owned several businesses in the retail, construction, and service industries. Mr. Spiegel has extensive experience working with both businesses and employees as well as non-profit organizations and takes great pride in his involvement. He is a current member of the Circle City Rotary and participated in the Riverside County Task Force to help reopen business during COVID. As the Corona Chamber of Commerce President, he

represents over 700 businesses that have a combined total of over 45,000 jobs. His expertise in working in the business sector will continue to be a great asset to the WDB.

Robert Spiegel has expressed interest to serve on the Riverside County Workforce Development Board as a private sector representative for the Fifth District. If reappointed, he will serve a two-year term effective September 23, 2024, and expiring September 23, 2026.
