BACKGROUND:

Summary

The County of Riverside (County) in cooperation with the cities of Jurupa Valley and Riverside are proposing to replace the existing Market Street Bridge over the Santa Ana River (Project), with a new bridge to enhance safety and improve traffic circulation. The Market Street Bridge is located within the City of Jurupa Valley and City of Riverside.

Although the Project is located within the jurisdictional boundaries of the City of Jurupa Valley and the City of Riverside, the Cities have designated the County as the agency responsible for the overall development of the project in a Service Agreement approved by the Board of Supervisors on December 6, 2016 (Agenda Item 3.39). Therefore, the County will provide the administrative, technical, managerial, and support services necessary for the development of the Project.

On February 7, 2017 (Agenda Item 3.34), the County Board of Supervisors executed an Engineering Services Agreement for the Replacement of the Market Street Bridge over the Santa Ana River, between the County and Dokken Engineering to complete the preliminary engineering and environmental clearance for this project. On August 25, 2019, the City of Jurupa Valley adopted and approved the California Environmental Quality Act (CEQA) Initial Study with Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program. The National Environmental Policy Act (NEPA) Categorical Exclusion was issued on November 25, 2019.

On June 23, 2020 (Agenda Item 3.33), the County Board of Supervisors executed Amendment 1 to the Engineering Services Agreement for the Replacement of the Market Street Bridge over the Santa Ana River, between the County and Dokken Engineering. Amendment No. 1 authorized Phase II, Phase III and Phase IV of the Project.

Amendment No. 2 is being processed to extend the time period of the Agreement to accomplish the delayed tasks including obtaining the necessary Environmental permits Section 404 and 408, final design, preparation of the bid documents, and design support during construction advertisement.

Impact on Residents and Businesses

Informal public information meetings will be held as necessary during the development of the project to keep the public informed. The project is expected to have minimum impact on the surrounding environment and the community during development and construction. The replacement bridge will be designed in accordance with the latest state of the art bridge design criteria.

AMENDMENT NO. 2 TO THE ENGINEERING SERVICES AGREEMENT

FOR REPLACEMENT OF MARKET STREET BRIDGE AT SANTA ANA RIVER (BR. NO. 56C-0024)

BETWEEN

COUNTY OF RIVERSIDE • TRANSPORTATION DEPARTMENT

AND

DOKKEN ENGINEERING

RECITALS

- A. COUNTY and ENGINEER have entered into an agreement entitled "Engineering Services Agreement for Replacement of Market Street Bridge at Santa Ana River (Br. No. 56C-0024) between County of Riverside
 Transportation Department and Dokken Engineering" that is dated February 7, 2017, Agenda Item 3.34, (hereinafter the "AGREEMENT").
- B. The AGREEMENT provides the terms and conditions, scope of services, schedule, and budget for the performance of professional and technical services necessary for the replacement of Market Street Bridge at Santa Ana River (hereinafter the "PROJECT").
- C. The AGREEMENT authorized Phase 1 of the PROJECT (Preliminary Engineering/Environmental Clearance/Technical Report).
- D. The AGREEMENT was amended on June 23, 2020, Agenda Item 3.33, via Amendment No. 1 to authorize Phase II (Plans, Specifications and Estimates), Phase III (Construction Bidding and Award Support), and Phase IV (Design Support During Construction) of the PROJECT(hereinafter the "AMENDMENT NO. 1"). ENGINEER was to complete Phase II, Phase III, and Phase IV of the PROJECT by December 31, 2024.
- E. During the environmental permitting process for the PROJECT under Section 404/408 with U.S. Army Corps of Engineers (USACE), the USACE began constructing the Riverside Levee Repair portion of the PROJECT within the PROJECT limits. The USACE required extensive coordination and re-initiation of

of Services.

Replacement of Market Street Bridge at Santa Ana River (Br. No. 56C-0024)

Section 7 Consultation for federally endangered species with U.S. Fish and Wildlife Service (USFWS) to ensure the PROJECT would not conflict and all cumulative impacts would be covered by one Biological Opinion, delaying issuance of the Section 404 and 408 permits for the PROJECT by up to two (2) years.

As a result, additional time is necessary for obtaining PROJECT approval from the USACE and other regulatory agencies and the parties desire to once again amend the AGREEMENT to extend the Schedule

F. This AMENDMENT NO. 2 extends the completion date of the AGREEMENT through June 30, 2029.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants hereinafter contained, the parties agree as follows:

- 1. The last sentence of the first paragraph of Appendix B Article BI• Introduction of the AGREEMENT, as amended, is hereby amended to extend the completion date from December 31, 2024 to June 30, 2029, as follows: "All covenants set forth in this AGREEMENT shall be completed by June 30, 2029, unless extended by supplemental agreement."
- 2. Except to the extent specifically modified or amended hereunder, all the terms, covenants and conditions of the AGREEMENT, as amended, shall remain in full force and effect between the parties hereto.
- 3. This AMENDMENT NO. 2 shall become effective upon signature of this AMENDMENT NO. 2 by both parties or December 3, 2024, whichever should come first.
- 4. This AMENDMENT NO. 2 may be executed in any number of counterparts, each of which shall be an original, but all of which together shall constitute one and the same instrument. Each party to this AMENDMENT NO. 2 agrees to the use of electronic signatures, such as digital signatures that meet the requirements of the California Uniform Electronic Transactions Act (("CUETA") Cal. Civ. Code §§ 1633.1 to 1633.17), for executing this AMENDMENT NO. 2. The parties further agree that the electronic signatures of the parties included in this AMENDMENT NO. 2 are intended to authenticate this writing and to have the same force and effect as manual signatures. Electronic signature means an electronic sound, symbol, or process attached to or logically associated with an electronic record and executed or adopted by a person

Replacement of Market Street Bridge at Santa Ana River (Br. No. 56C-0024) with the intent to sign the electronic record pursuant to the CUETA as amended from time to time. The CUETA authorizes use of an electronic signature for transactions and contracts among parties in California, including a government agency. Digital signature means an electronic identifier, created by computer, intended by the party using it to have the same force and effect as the use of a manual signature, and shall be reasonably relied upon by the parties. For purposes of this section, a digital signature is a type of "electronic signature" as defined in subdivision (i) of Section 1633.2 of the Civil Code.

IN WITNESS HEREOF, the parties hereto have caused this AMENDMENT NO. 2 to the AGREEMENT to be duly executed this day and year first written above.


