

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Dresses & Dreams Project - \$1,000** will be used to support efforts to provide dresses to local high school girls that are going through hardships or circumstances which leave them unable to purchase a formal dress and accessories to attend their prom. 100-120 girls are expected to sign up for assistance this year.
2. **Baseball Resource Group - \$10,000** will be used to fund a 6-week training program for youth players aged 8 to 12, held at the Lakeland Village Sports Park.
3. **Habitat for Humanity Inland Valley - \$5,000** will support the financial literacy education program as well as the home repair and preservation program, which helps low-income homeowners obtain exterior repairs.
4. **Studio 395 Foundation, Inc. - \$25,000** will be used to support local programming and services in the Lakeland Village Community.
5. **The Grove Community Church - \$75,000** will be used to support local programming and services in the Mead Valley Community.
6. **The Grove Community Church - \$45,000** will be used to support local programming and services in the Good Hope Community.
