Approve the grant and obligation of \$151,149 in Fourth District's American Rescue Plan Act (ARPA) allocation to the Housing Authority of the County of Riverside to cover renovation and weekly maintenance costs for two (2) years for Jack E. Marlowe Park, located in the unincorporated community of Ripley at 24699 School Road;
3. Approve the attached Subrecipient Grant Agreement for the Use of American Rescue Plan Act (ARPA) Funds (Subrecipient Agreement) and authorize the Chair to execute the Subrecipient Agreement on behalf of the County;
4. Authorize the Director of Housing and Workforce Solutions (HWS) or designee, to administer all actions necessary related to the administration of the Subrecipient Agreement, including signing any subsequent related documents, subject to approval as to form by County Counsel; and
5. Direct the Clerk of the Board to file the Notice of Exemption (NOE) with the County Clerk and the State Clearinghouse at the Office of Planning and Research (OPR) within five (5) business days of approval.

BACKGROUND:

Summary

The Housing Authority of the County of Riverside (HACR) is a public entity that was formed in 1942 to provide federally subsidized housing and housing assistance to low-income families, within the County of Riverside. HACR is subject to the requirements of Title 24 of the Code of Federal Regulations ("CFR"), Housing Authorities Law (Part 2 of Division 24 of the California Health and Safety Code commencing with Section 34200 et seq.) and HACR's own procurement policy.

HACR is a committed partner in the community's effort to revitalize neighborhoods and foster economic development, as well as to provide quality, affordable housing. The proposed project will completely renovate Jack E. Marlowe Park, located at 24699 School Road, Ripley, within the County of Riverside, State of California. After the renovation of Jack E. Marlowe Project is complete, the contractor will provide landscape maintenance for two (2) years with no increases in maintenance services.

HACR has applied to the County of Riverside (County) for ARPA funding in the amount of \$151,149 to pay for the renovation of the Jack E. Marlowe Park and once complete, the HACR will provide weekly landscape maintenance for two (2) years. The attached Subrecipient Agreement obligates \$151,149 of the ARPA funds.

County Counsel has reviewed and approved as to form the attached form of Subrecipient Grant Agreement for the Use of ARPA Funds. Staff recommends that the Board approve the form of Subrecipient Grant Agreement.

California Environmental Quality Act (CEQA):

This project will provide a comprehensive renovation of the Jack E. Marlowe Park. The project is exempt from CEQA pursuant to California Code of Regulations, Title 14, Section 15301 Existing Facilities Exemption. This exemption includes the operation, repair, maintenance, leasing, or minor alteration of existing public or private structures or facilities, provided the exemption only involves negligible or no expansion of the previous site's use. The project as proposed is for renovation and continued maintenance. There will be no expansion of the existing use of the project. Additionally, the project is exempt from CEQA pursuant to Section 15061(b)(3) as there is no possibility the project will have a significant impact on the environment.

Impact on Residents and Businesses

Approving this item will have a positive impact on the citizens and businesses of Riverside County. The proposed project is expected to accommodate a wide range of recreation needs based on the surrounding community. Additionally, the newly renovated Jack E. Marlow Project will create a space for all community members to congregate safely and enjoy nature; kids can play under their parents' watchful eye and community members can improve their health with equipment. Jack E. Marlowe Park will have amenities to keep visitors of all ages active and engaged. This improvement will positively impact the overall health of residents and improve the surrounding neighborhood.

SUPPLEMENTAL:

Additional Fiscal Information

On October 19, 2021 (Minute Order 3.5), the Board of Supervisors allocated \$50,000,000 of ARPA funds for the purpose of addressing homelessness through development of affordable housing and providing shelter. The allocation was divided evenly between each Supervisorial District, \$10,000,000 per district (1st ARPA Allocation). The funding allocated by the Board was the State and Local Fiscal Recovery Funds (SLFRF) allocated to the County as part of the American Rescue Plan Act (ARPA) of 2021 (Pub. L 117-2). These ARPA funds are to focus on projects and/or programs that serve as a pathway to create affordable housing with necessary supporting infrastructure to assist low-income communities disproportionately affected by the COVID-19 pandemic.

**SUBMITTAL TO THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE,
STATE OF CALIFORNIA**

On October 4, 2022 (Minute Order 3.44), the Board of Supervisors allocated an additional \$165,000,000 in ARPA funding (2nd ARPA allocation) as part of the American Rescue Plan Act of 2021 (Pub. L 117-2). Of this 2nd ARPA allocation, (referred to as Round 2 Funding) \$33,000,000 was equally distributed to each district.

Funding for this grant will be funded out of the Fourth District's 2nd ARPA allocation. No impact upon the County's General Fund; the County's contribution to the Project will be fully funded with American Rescue Plan Act (ARPA) funds.

Reasons Why Project is Exempt: The proposed project has been evaluated and determined to be exempt from the California Environmental Quality Act (CEQA) pursuant to California Health and Safety Code Sections 50675.1.1 and 50675.1.2 and State CEQA Guidelines Section 15061 (b)(3) (Common sense exemption). Notwithstanding any other law, the California Environmental Quality Act (Division 13 (commencing with Section 21000) of the Public Resources Code) shall not apply to any project, including a phased project, funded pursuant to Section 50675.1.1 if certain requirements described in Section 50675.1.2, if applicable, are satisfied. 2 **SUBRECIPIENT GRANT AGREEMENT FOR THE USE OF**
3 **AMERICAN RESCUE PLAN ACT (ARPA) FUNDS**

4 THIS SUBRECIPIENT GRANT AGREEMENT for the use of American Rescue Plan
5 Act (“ARPA”) funds (“Agreement”) is entered into on this 5th day of **November, 2024**,
6 by and between, the **COUNTY OF RIVERSIDE**, a political subdivision of the State of
7 California, hereinafter referred to as "COUNTY", and the **HOUSING AUTHORITY OF THE**
8 **COUNTY OF RIVERSIDE**, a public entity, corporate and politic, hereinafter referred to as
9 "SUBRECIPIENT." COUNTY and SUBRECIPIENT are collectively referred to herein as
10 “Parties” and individually as a “Party.” This Agreement, for the use of U.S. Department of the
11 Treasury (“U.S. Treasury”) Coronavirus State and Local Fiscal Recovery Funds (“SLRF”) under the American Rescue Plan Act of 2021 (Pub. L. 117-2), amending Title VI of the Social Security Act (42 U.S.C. 801 et seq.), hereinafter “ARPA” or the “Act”, is made and entered into as of the Effective Date (defined herein).

16 **RECITALS**

17 **WHEREAS**, on March 11, 2021, to address the negative economic impacts of the COVID-
18 19 pandemic, President Joseph R. Biden signed into law the Act, and on January 6, 2022, the
19 U.S. Treasury adopted a Final Rule implementing the “SLFRF”;

20 **WHEREAS**, state, territorial, local and tribal governments must comply with the Final
21 Rule by April 1, 2022 when the Final Rule takes effect;

22 **WHEREAS**, the Act, the regulations promulgated in 31 CFR Part 35, and the Final Rule
23 (collectively, the “ARPA Rules”) provide that SLFRF may be used to cover costs that are
24 necessary expenditures incurred due to the public health emergency of the COVID-19 pandemic;

25 **WHEREAS**, on October 19, 2021, via Minute Order 3.5, the Board of Supervisors of the
26 County of Riverside approved allocating \$50,000,000 in ARPA funds to increase shelter
27 capacity, permanent supportive housing units, and affordable housing to help address
28 homelessness;

1 **WHEREAS**, on October 4, 2022 (Minute Order 3.44), the Board approved the second
2 installment allocation of ARPA funds to focus on projects and/or programs that serve as a
3 pathway to create affordable housing with necessary supporting infrastructure to assist low-
4 income communities disproportionately affected by the COVID-19 pandemic;

5 **WHEREAS**, SUBRECIPIENT is proposing to utilize ARPA Grant funds to pay for the
6 Jack E. Marlowe Renovation (“Project”). The proposed project will completely renovate the
7 Jack E. Marlowe Park, located at 24699 School Road, Ripley, within the County of Riverside,
8 State of California. After the renovation of Jack E. Marlowe Project is complete, the contractor
9 will provide landscape maintenance for two (2) years with no increases in maintenance
10 services;

11 **WHEREAS**, Jack E. Marlowe Park is a community park located in unincorporated
12 community of Ripley. The proposed project is expected to accommodate a wide range of
13 recreation needs based on the surrounding community. Additionally, the renovations to Jack E.
14 Marlow Park will create a space for all community members to congregate safely and enjoy
15 nature; kids can play under their parent’s watchful eye and community members can improve
16 their health with equipment, all relaxing environments. Jack E. Marlowe Park will have
17 amenities to keep visitors of all ages active and engaged. This improvement will positively
18 impact the overall health of residents and improve the surrounding neighborhood;

19 **WHEREAS**, the purpose of this Agreement is for COUNTY to provide financial
20 assistance to SUBRECIPIENT in the maximum grant amount of One Hundred Fifty-One
21 Thousand One Hundred and Forty-Nine Dollars (\$151,149.00) consisting of SLFRF funds, to
22 fund a portion of the Project’s costs, as more fully described herein;

23 **WHEREAS**, pursuant to 31 CFR Part 35.6, one of the Eligible Uses (as defined under
24 ARPA Rules) of the SLFRF funds a program, service, capital expenditure, or other assistance
25 that is provided to a disproportionately impacted household, population, or community,
26 including: Investments in communities to promote improved health outcomes and public safety
27 such as parks; Facilities and equipment related to the provision of these services to the
28 disproportionately impacted household, population, or community;

1 **WHEREAS**, SUBRECIPIENT, as a public entity, is eligible under the Act to receive
2 ARPA funds to provide those services that conform with the Eligible Uses of the Act as
3 described herein;

4 **WHEREAS**, SUBRECIPIENT is eligible under the Acts to receive ARPA funds to
5 perform those activities described herein; and

6 **WHEREAS**, the SUBRECIPIENT has submitted its proposal to the COUNTY for
7 funding the activities described herein.

8 **NOW THEREFORE, the COUNTY and SUBRECIPIENT** mutually agree as follows:

9 1. PURPOSE. SUBRECIPIENT shall carry out the Project described in **Exhibit**
10 **“A”**, by utilizing the sum of One Hundred and Fifty-One Thousand One Hundred Forty-Nine
11 Dollars (\$151,149.00) in ARPA Program funds (“ARPA Grant”), as set forth and in the manner
12 provided in the Scope of Work attached hereto as **Exhibit "A"** and incorporated herein by this
13 reference. SUBRECIPIENT shall undertake and complete the ARPA activities required herein
14 and at the time frame as set forth in the Implementation Schedule and Budget Attachment,
15 attached hereto as **Exhibit “B”** and incorporated herein by this reference. SUBRECIPIENT
16 shall utilize the ARPA Grant as required herein and pursuant to the Act and ARPA rules and
17 regulations. Any and all work or services provided hereunder shall be in full conformity with
18 the Act and the ARPA Rules. Any and all work or services provided hereunder shall be in full
19 conformity with the Act and any amendments thereto and the federal regulation and guidelines
20 now or hereinafter enacted pursuant to the Act..

21 2. TERM. The term of this Agreement shall be for a period commencing on the
22 Effective Date, and terminating on September 30, 2026, unless sooner terminated as provided
23 in **Section 5** herein.

24 3. DISBURSEMENT OF FUNDS. The COUNTY shall pay to the SUBRECIPIENT
25 the ARPA Grant as specified in **Section 1** above for all approved costs. The SUBRECIPIENT
26 shall not submit more often than monthly to the ARPA Administrator of COUNTY a certified
27 statement setting forth in detail the expenditures made for which it is asking reimbursement
28 along with pertinent supporting documentation. The COUNTY shall promptly review the
monthly expenditure statement and reimburse the SUBRECIPIENT for the approved costs in

1 accordance with its usual accounting procedures. The COUNTY may require from
2 SUBRECIPIENT such supporting documentation as may be necessary and appropriate for the
3 COUNTY to make its determination as to allowable costs. Each disbursement of ARPA Grant
4 funds shall be made within thirty (30) days after SUBRECIPIENT has submitted its statement
5 of expenditure.

6 4. RECORDS AND INSPECTIONS. The SUBRECIPIENT shall maintain financial,
7 programmatic, statistical, client data, and other supporting records of its operations and financial
8 activities in accordance with the *Uniform Administrative Requirements, Cost Principles, and*
9 *Audit Requirements for Federal Awards* (2 (CFR) Part 200) and 601(d) of the Social Security
10 Act.

11 Pursuant to 2 CFR Section 200.333, such records shall be open to inspection and audit by
12 the authorized representatives of the COUNTY, the U.S. Treasury, and the Controller General,
13 during regular working hours.

14 Said records shall be retained for a period of less than five (5) years from the date that the
15 activity or program funded with the ARPA Grant is closed out by the COUNTY. Exceptions to
16 the five (5) year retention period requirements pursuant to 2 CFR 200.333:

- 17 i. if any litigation, claim, or audit is started prior to the expiration of the five
18 (5) year period;
- 19 ii. when the SUBRECIPIENT is notified in writing by the COUNTY, U.S.
20 Department of Treasury, or other Federal agency to extend the retention period;
- 21 iii. records for equipment or real property acquired with ARPA Grant funds
22 must be retained for five (5) years after final disposition;
- 23 iv. when the records are transferred by the SUBRECIPIENT to the COUNTY,
24 HUD, or other Federal agency, the five (5) year period is not applicable;
- 25 v. Reserved;
- 26 vi. Reserved.

27 SUBRECIPIENT shall obtain an external audit in accordance with the Uniform
28 Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (2
CFR Section 200.500). Audits shall usually be performed annually but not less frequently than

1 every two years. Nonprofit institutions and government agencies that expend less than \$750,000
2 a year in federal awards are exempt from federal audit requirements, but records must be
3 available for review by appropriate officials of the federal grantor agency or sub-granting entity.
4 The audit report shall be submitted to the COUNTY within 180 days after the end of the
5 COUNTY'S fiscal year.

6 SUBRECIPIENT shall maintain a separate account for ARPA Grant funds.

7 5. TERMINATION.

8 a. SUBRECIPIENT may not terminate this Agreement except upon express
9 written consent of COUNTY, pursuant to 2 CFR Section 200.339 (a)(3). Said notice shall
10 include the effective date thereof.

11 b. Notwithstanding the provisions of **Section 5a** above, COUNTY may
12 suspend or terminate this Agreement forthwith for cause upon a ten (10) day written notice to
13 SUBRECIPIENT of the action being taken. Cause shall be established as follows:

14 (i) In the event SUBRECIPIENT fails to perform the covenants herein
15 contained at such times and in such manner as provided in this Agreement; or

16 (ii) In the event there is a conflict with any federal, state or local law,
17 ordinance, regulation or rule rendering any of the provisions of this Agreement invalid or
18 untenable; or

19 (iii) In the event the funding from the U.S. Department of Treasury,
20 referred to in the recitals herein, is reduced, terminated or otherwise becomes unavailable.
21 COUNTY shall provide written notice to SUBRECIPIENT within five (5) days from the date
22 U.S. Department of Treasury reduces, suspends, or terminates the ARPA funding. This
23 Agreement shall be either terminated or amended to reflect said reduction in ARGA Grant
24 funds.

25 c. This Agreement may be terminated and/or funding suspended, in whole or
26 in part, for cause in accordance with the Uniform Administrative Requirements, Cost Principles,
27 and Audit Requirements for Federal Awards (2 CFR Section 200.339). Cause shall be based on
28 the failure of the SUBRECIPIENT to materially comply with either the terms or conditions of
this Agreement. Upon suspension of funding, the SUBRECIPIENT agrees not to incur any costs

1 related thereto, or connected with, any area of conflict from which the COUNTY has
2 determined that suspension of funds is necessary. SUBRECIPIENT acknowledges that failure
3 to comply with Federal statutes, regulations, or the terms and conditions of this Agreement may
4 be considered by the COUNTY in evaluating future ARPA and non-ARPA funding applications
5 submitted by SUBRECIPIENT.

6 d. Upon termination of this Agreement, SUBRECIPIENT agrees to return
7 any unencumbered funds which it has been provided by COUNTY. In accepting said funds,
8 COUNTY does not waive any claim or cause of action it may have against SUBRECIPIENT
9 for breach of this Agreement.

10 e. Upon termination of this Agreement, SUBRECIPIENT shall not incur any
11 obligations after the effective date of such termination, unless expressly authorized in writing
12 by COUNTY in the notice of termination.

13 6. RESERVED.

14 7. PAYMENT OF FUNDS. The Board of Supervisors of the COUNTY shall
15 determine the final disposition and distribution of all funds received by COUNTY under the
16 Acts. COUNTY, through its Department of Housing and Workforce Solutions, shall make
17 payments of ARPA funds to SUBRECIPIENT as designated in the Implementation Schedule
18 and Budget Attachment, attached hereto as **Exhibit "B"** for the Project as more fully described
19 in the Scope of Work, attached hereto as **Exhibit "A"**.

20 All disbursements of ARPA Grant funds will be made as follows:

21 a. Payments shall be made to a SUBRECIPIENT upon written request after
22 this Agreement has been fully executed on a reimbursement basis and made within thirty (30)
23 days after the SUBRECIPIENT has submitted written notice identifying payments made and
24 requesting reimbursement. Payments shall be based on actual approved and documented
25 expenses by SUBRECIPIENT.

26 b. In no event shall COUNTY be held liable for expenses incurred by
27 SUBRECIPIENT in excess of the ARPA Grant allocation as set forth in **Section 1, PURPOSE,**
28 above.

c. Reserved.

1 d. No later than thirty (30) days prior to the termination of this Agreement,
2 SUBRECIPIENT shall provide COUNTY with its estimate of the amount of funds which will
3 remain unexpended upon such termination. Notwithstanding any provision contained in this
4 **Section 7**, COUNTY shall, after a thirty (30) day written notice is given SUBRECIPIENT, have
5 the right to (1) reduce the payment of funds hereunder, (2) renegotiate the actual levels of
6 expenditures in the event SUBRECIPIENT'S rate of expenditures will result in unexpended
7 funds at the expiration of this Agreement, and (3) reprogram funds associated with a project on
8 which there has been no substantial progress or activity.

9 8. PERFORMANCE EVALUATION. SUBRECIPIENT shall permit COUNTY,
10 State or Federal officials to monitor, assess, or evaluate SUBRECIPIENT'S performance under
11 this Agreement on an as needed basis to be determined by the COUNTY based on monitoring
12 and performance evaluations. Said monitoring, assessment, or evaluation to include, but are
13 not limited to, audits, inspections within the program area, and interviews with
14 SUBRECIPIENT'S employees, agents, independent contractors, and subcontractors providing
15 the services under this Agreement and recipients thereof.

16 9. COMPLETION SCHEDULE. SUBRECIPIENT shall proceed consistent with the
17 implementation schedule ("Implementation Schedule and Budget Attachment") as set forth in
18 Exhibit "B", as such schedule may be amended by both Parties in writing.

19 10. RESERVED.

20 11. RESERVED.

21 12. ASSIGNABILITY. SUBRECIPIENT shall not assign any of its rights, duties, or
22 obligations pursuant to this Agreement to any person or entity without the prior written consent
23 of COUNTY in its sole and absolute discretion, including but not limited to the ability to
24 subcontract all or a portion of its rights, duties, and obligations hereunder.

25 13. INSURANCE. Without limiting or diminishing the SUBRECIPIENT'S obligation
26 to indemnify or hold the COUNTY harmless, SUBRECIPIENT shall procure and maintain or
27 cause to be maintained, at its sole cost and expense, the following insurance coverage's during
28 the term of this Agreement.

 a. Workers' Compensation:

1 If the SUBRECIPIENT has employees as defined by the State of California, the
2 SUBRECIPIENT shall maintain statutory Workers' Compensation Insurance (Coverage A) as
3 prescribed by the laws of the State of California. Policy shall include Employers' Liability
4 (Coverage B) including Occupational Disease with limits not less than \$1,000,000 per person
5 per accident. The policy shall be endorsed to waive subrogation in favor of the County of
6 Riverside.

7 b. Commercial General Liability:

8 Commercial General Liability insurance coverage, including but not limited to,
9 premises liability, contractual liability, products and completed operations liability, personal and
10 advertising injury, and cross liability coverage, covering claims which may arise from or out of
11 SUBRECIPIENT 'S performance of its obligations hereunder. Policy shall name the County of
12 Riverside as Additional Insured. Policy's limit of liability shall not be less than \$2,000,000 per
13 occurrence combined single limit. If such insurance contains a general aggregate limit, it shall
14 apply separately to this agreement or be no less than two (2) times the occurrence limit.

15 c. Vehicle Liability:

16 If vehicles or mobile equipment are used in the performance of the obligations
17 under this Agreement, then SUBRECIPIENT shall maintain liability insurance for all owned,
18 non-owned or hired vehicles so used in an amount not less than \$1,000,000 per occurrence
19 combined single limit. If such insurance contains a general aggregate limit, it shall apply
20 separately to this Agreement or be no less than two (2) times the occurrence limit. Policy shall
21 name the County of Riverside as Additional Insured.

22 d. General Insurance Provisions - All lines:

23 (i). Any insurance carrier providing insurance coverage hereunder shall be
24 admitted to the State of California and have an A M BEST rating of not less than A: VIII (A:8)
25 unless such requirements are waived, in writing, by the County of Riverside's Risk Manager. If
26 the County's Risk Manager waives a requirement for a particular insurer such waiver is only
27 valid for that specific insurer and only for one policy term.

28 (ii). The SUBRECIPIENT'S insurance carrier(s) must declare its insurance self-
insured retentions. If such self-insured retentions exceed \$500,000 per occurrence such
retentions shall have the prior written consent of the County Risk Manager before the

1 commencement of operations under this Agreement. Upon notification of self-insured retention
2 unacceptable to the COUNTY, and at the election of the County's Risk Manager,
3 SUBRECIPIENT'S carriers shall either; 1) reduce or eliminate such self-insured retention as
4 respects this Agreement with the COUNTY, or 2) procure a bond which guarantees payment of
5 losses and related investigations, claims administration, and defense costs and expenses.

6 (iii). SUBRECIPIENT shall cause SUBRECIPIENT'S insurance carrier(s) to
7 furnish the County of Riverside with either 1) a properly executed original Certificate(s) of
8 Insurance and certified original copies of Endorsements effecting coverage as required herein,
9 and 2) if requested to do so orally or in writing by the County Risk Manager, provide original
10 Certified copies of policies including all Endorsements and all attachments thereto, showing such
11 insurance is in full force and effect. Further, said Certificate(s) and policies of insurance shall
12 contain the covenant of the insurance carrier(s) that thirty (30) days written notice shall be given
13 to the County of Riverside prior to any material modification, cancellation, expiration or
14 reduction in coverage of such insurance. In the event of a material modification, cancellation,
15 expiration, or reduction in coverage, this Agreement shall terminate forthwith, unless the County
16 of Riverside receives, prior to such effective date, another properly executed original Certificate
17 of Insurance and original copies of endorsements or certified original policies, including all
18 endorsements and attachments thereto evidencing coverage's set forth herein and the insurance
19 required herein is in full force and effect. *SUBRECIPIENT shall not commence operations until*
20 *the COUNTY has been furnished original Certificate (s) of Insurance and certified original*
21 *copies of endorsements and if requested, certified original policies of insurance including all*
22 *endorsements and any and all other attachments as required in this **Section 13**. An individual*
23 *authorized by the insurance carrier to do so on its behalf shall sign the original endorsements*
24 *for each policy and the Certificate of Insurance.*

25 (iv). It is understood and agreed to by the Parties hereto that the
26 SUBRECIPIENT'S insurance shall be construed as primary insurance, and the COUNTY'S
27 insurance and/or deductibles and/or self-insured retentions or self-insured programs shall not be
28 construed as contributory.

(v). If, during the term of this Agreement or any extension thereof, there is a

1 material change in the Scope of Services; or, there is a material change in the equipment to be
2 used in the performance of the Scope of Services or, the term of this Agreement, including any
3 extensions thereof, exceeds five (5) years, the COUNTY reserves the right to adjust the types of
4 insurance required under this Agreement and the monetary limits of liability for the insurance
5 coverage's currently required herein, if; in the County Risk Manager's reasonable judgment, the
6 amount or type of insurance carried by the SUBRECIPIENT has become inadequate.

7 (vi). SUBRECIPIENT shall pass down the insurance obligations contained
8 herein to all tiers of subcontractors working under this Agreement.

9 (vii). The insurance requirements contained in this Agreement may be met with
10 a program(s) of self-insurance acceptable to the COUNTY.

11 (viii). SUBRECIPIENT agrees to notify COUNTY of any claim by a third party
12 or any incident or event that may give rise to a claim arising from the performance of this
13 Agreement.

14 14. HOLD HARMLESS AND INDEMNIFICATION. SUBRECIPIENT shall
15 indemnify and hold harmless the County of Riverside, its Agencies, Districts, Special Districts
16 and Departments, their respective directors, officers, Board of Supervisors, elected and
17 appointed officials, employees, agents and representatives individually and collectively
18 hereinafter referred to as "Indemnitees" from any liability whatsoever, based or asserted upon
19 any acts or services of SUBRECIPIENT, its officers, employees, subcontractors, agents or
20 representatives arising out of or in any way relating to this Agreement, including but not limited
21 to property damage, bodily injury, or death or any other element of any kind or nature whatsoever
22 arising from the performance of SUBRECIPIENT, its officers, agents, employees,
23 subcontractors, or representatives from this Agreement. SUBRECIPIENT shall defend, at its
24 sole expense, all costs and fees including, but not limited, to attorney fees, cost of investigation,
25 defense and settlements or awards, the Indemnitees in any claim or action based upon such
26 alleged acts or omissions.

27 With respect to any action or claim subject to indemnification herein by SUBRECIPIENT,
28 SUBRECIPIENT shall, at their sole cost, have the right to use counsel of their own choice and
shall have the right to adjust, settle, or compromise any such action or claim without the prior

1 consent of COUNTY; provided, however, that any such adjustment, settlement or compromise
2 in no manner whatsoever limits or circumscribes SUBRECIPIENT'S indemnification to
3 Indemnitees as set forth herein.

4 SUBRECIPIENT'S obligation hereunder shall be satisfied when SUBRECIPIENT has
5 provided to COUNTY the appropriate form of dismissal relieving COUNTY as Indemnitees
6 from any liability for the action or claim involved.

7 The specified insurance limits required in this Agreement shall in no way limit or
8 circumscribe SUBRECIPIENT'S obligations to indemnify and hold harmless the Indemnitees
9 herein from third party claims. The hold harmless and indemnification obligation set forth herein
10 shall survive the termination and expiration of this Agreement.

11 15. FEDERAL REQUIREMENTS. SUBRECIPIENT shall comply with the
12 provisions of the Act and ARPA Rule and any applicable amendments thereto and the federal
13 regulations and guidelines now or hereafter enacted pursuant to the Act. SUBRECIPIENT shall
14 abide by the provisions of the COUNTY'S ARPA program policies.

15 16. ENVIRONMENTAL REVIEW. SUBRECIPIENT does not assume the
16 COUNTY'S Federal environmental responsibilities described at 24 CFR 570.604. Pursuant to
17 Section 15051 (d) of the Title 14 of the California Administrative Code, COUNTY is designated
18 as the lead agency for the Project that is the subject matter of this Agreement.

19 17. RESERVED.

20 18. COMPLIANCE WITH LAWS, REGULATIONS, NONDISCRIMINATION,
21 AND EQUAL OPPORTUNITY.

22 By executing this Agreement, SUBRECIPIENT hereby certifies that it will adhere to and comply
23 with all federal, state and local laws, regulations and ordinances. In particular, SUBRECIPIENT
24 shall comply with the Act and ARPA Rules and the following as they may be applicable to
25 SUBRECIPIENT in connection with the ARPA Grant funds:

26 a. Compliance with Executive Order 11246 of September 24, 1965, entitled

28 successors in interest shall be bound by all the provisions contained in this Agreement, and all
of the Parties thereto shall be jointly and severally liable hereunder.





Scope of Work

1. The work under this Contract shall be performed at the Jack E. Marlowe located in the unincorporated community of Ripley, County of Riverside, State of California ("Property") and shall include furnishing all labor, material, equipment, tools, supplies, and services and incidentals, and performing all work necessary for the Renovation of the Jack E. Marlowe Park.
2. Jack E. Marlowe Park Renovation Project Overview: This Renovation Project will include, but are not limited to, any portion of the following:
 - a. Initial planning and site review: Verify existing conditions related to the existing project at hand at the proposed site; see scope of work for final determination for project completion restoration.
 - b. Prepare a detailed work plan indicating required and recommended milestones, deliverables and submittals, review timeframes, and critical actions or decisions required of HACR. Make modifications and updates to the work plans as requested by HACR staff.
 - c. Coordinate design and landscape/restoration activities with HACR Development staff.
