3. Direct the Clerk of the Board to record the Notice of Completion.



BACKGROUND:

Summary

The Director of Transportation Department entered into an emergency contract on August 29, 2023, with Martin Marietta San Diego Aggregates LLC dba ATP General Engineering Contractors, of San Diego, California for the Emergency Storm Damage Repair Work on Mission Creek Road and Worsley Road, North of City of Desert Hot Springs area of Riverside County. On September 26, 2023, Agenda Item 3.35, the Board of Supervisors received and filed this emergency contract.

The original authorized amount of the contract was \$1,500,000. The total amount of the contract came in at \$1,223,878.00 which was 18.4% less than the originally authorized amount. The reduction of the total cost was the result of using less quantities than anticipated to complete the work.

Per the Director of the Transportation Department, additional emergency road work repair locations were added along Temescal Canyon Road; Ave 52 and Jackson Street.

The work was completed in conformance with the plans and specifications on April 12, 2024.

Impact on Residents and Businesses




