**BACKGROUND:**

**Summary**

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the April 26, 2022 public auction sale. The deed conveying title to the purchasers at the auction was recorded July 7, 2022. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 19, 2022 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received one claim for excess proceeds:

1. Claim from Carol A. Hahn, heir to the Estate of Gary Scott Hahn, based on a Quitclaim Deed recorded July 28, 2008 as Instrument No. 2008-0409727, a Declaration for Collection or Transfer of Small Estate without Administration under Probate code 13101 notarized October 7, 2022, and a Certificate of Death for Gary Hahn.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Carol A. Hahn, heir to the Estate of Gary Scott Hahn, be awarded excess proceeds in the amount of \$47,105.69. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimant by certified mail.

**Impact on Residents and Businesses**

Excess proceeds will be released to the heir to the Estate of the last assesse of the property.
