

BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the April 26, 2022 public auction sale. The deed conveying title to the purchasers at the auction was recorded July 7, 2022. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 19, 2022 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received one claim for excess proceeds:

1. Claim from Crystal Nassar, Authorized agent for Margaret A. Smith, heir to the Estate of Richard L. Smith, last assessee based on an Authorization for Agent to Collect Excess Proceeds notarized April 9, 2024, a Quitclaim Deed recorded May 10, 1995 as Instrument No. 1995-148332, an Affidavit – Death of Joint Tenant recorded September 11, 2001 as Instrument No. 2001-440488, an Affidavit for Collection of Personal Property notarized April 26, 2024, and a Certificate of Death of Richard Louis Smith.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Crystal Nassar, Authorized agent for Margaret A. Smith, heir to the Estate of Richard L. Smith, last assessee be awarded excess proceeds in the amount of \$73,205.34. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimant by certified mail.

Impact on Residents and Businesses

Excess proceeds will be released the heir of the last assessee of the property.
