## BACKGROUND:

## <u>Summary</u>

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the April 26, 2022 public auction sale. The deed conveying title to the purchasers at the auction was recorded July 7, 2022. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 19, 2022 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received three claims for excess proceeds:

- Claim from Wayne S. Guralnick, Attorney for Casas Las Valles Owner's Association based on a Notice of Assessment Lien recorded July 30, 2018 as Instrument No. 2018-0305205.
- Claim from Kenosian & Miele, LLP, Attorneys for Unifund CCR Partners based on an Application for and Renewal of Judgment recorded January 19, 2021 as Instrument No. 2021-0033945.
- Claim from Global Discoveries, Ltd, Assignee for Jorge Moreno based on an Assignment of Right to Collect Excess Proceeds notarized June 1, 2023 and an Interspousal Transfer Deed recorded August 6, 2009 as Instrument No. 2009-0410692.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Wayne S. Guralnick, Attorney for Casas Las Valles Owner's Association be awarded excess proceeds in the amount of \$21,732.00, Kenosian & Miele, LLP, Attorneys for Unifund CCR Partners be awarded excess proceeds in the amount of \$31,974.62, and Global Discoveries, Ltd, Assignee for Jorge Moreno be awarded excess proceeds in the amount of \$66,221.05. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.
