#### BACKGROUND:

## Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the April 26, 2022 public auction sale. The deed conveying title to the purchasers at the auction was recorded July 7, 2022. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 19, 2022 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received two claims for excess proceeds:

- 1. Claim from Witkin & Neal, Inc., as Agent for Sierra Dawn Estates Homeowners Association based on a Notice of Delinquent Assessment Lien recorded June 4, 2021 as Instrument No. 2021-0340102.
- 2. Claim from Claudia Velarde based on a Quitclaim Deed recorded June 5, 2014 as Instrument No. 2014-0207243.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Witkin & Neal, Inc., as Agent for Sierra Dawn Estates Homeowners Association be awarded excess proceeds in the amount of \$22,555.26 and Claudia Velarde be awarded excess proceeds in the amount of \$29,969.42. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

### Impact on Residents and Businesses

Excess proceeds will be released to a lienholder and the last assessees of the property.
