4. **Direct** the Clerk of the Board to cause a certified copy of this resolution to be recorded in the office of the Recorder of the County of Riverside, California.



C.E.O. RECOMMENDATION: Approve

BACKGROUND:

In accordance with State Assembly Bill No. 2022, effective January 1, 2025, the term "squaw" must be removed from all geographic features and place names in California. In compliance with this mandate, the County of Riverside, in consultation with the California Advisory Committee on Geographic Names (CACGN), has designated Púwish Court (Private Street) as the replacement name for Sq___ Peak Court (Private Street).

Sq___ Peak Court is a privately maintained road located in the Lake Riverside area of unincorporated Riverside County. This road is dedicated but not accepted, and seven properties are currently addressed with this street name. GIS Addressing has reviewed the request and confirmed that there are no conflicts with the proposed new name.

To ensure compliance with AB 2022, the County conducted mandatory consultation meetings with Tribal Nations and CACGN. Fourteen Tribal Nations were contacted via email, phone, and certified mail. Three tribes—Cahuilla Band of Mission Indians, Soboba Band of Luiseno Indians, and Pala Band of Mission Indians—responded and participated in two virtual consultation meetings held on May 15, 2024, and June 6, 2024. These meetings were required under AB 2022 to ensure the renaming process was inclusive and culturally appropriate.

During the tribal consultations, three culturally significant names were recommended as replacement options. Each option includes the ancestral name and its English equivalent:

Púwish (Roadrunner)

Tu'ket (Bobcat)

Tu'chill (Hummingbird)

The goal of this renaming effort, consistent with AB 2022, is to use the ancestral name to honor and recognize the cultural heritage, languages, and traditions of the region's indigenous communities.

These recommendations were submitted to CACGN on July 1, 2024, and reviewed during a mandatory public meeting on October 1, 2024, as stipulated by AB 2022. CACGN approved the tribes' preferred name, Púwish Court, as the replacement.

The Transportation Department recommends approval of this item.

County Counsel has approved resolution Number 2025-017 as to form.

Impact on Residents and Businesses

There are currently seven properties addressed with Sq___ Peak Court (Private Street).

This street name change will have no impact on local businesses.

Additional Fiscal Information

All fees are paid by the Gas Tax. There is no General Fund obligation.

Exempt Status: California Environmental Quality Act (CEQA) Guidelines, Section 15061(b)(3), General Rule "Common Sense" Exemption. Not a "project" as defined under State CEQA Guidelines, Section 15060(c).

Reasons Why Project is Exempt: Changing the name of a street has been determined to not be a "project" as defined under State CEQA Guidelines section 15060(c). However, even if it was determined to be a project under CEQA for analysis purposes, the project is exempt from the provisions of CEQA specifically by the State CEQA Guidelines as identified below. The renaming of the existing roadway will not result in any specific or general exceptions to the use of the categorical exemption as detailed under State CEQA Guidelines Section 15300.2. The project will not cause any impacts to scenic resources, historic resources, or unique sensitive environments. Further, no unusual circumstances or potential cumulative impacts would occur that may reasonably create an environmental impact. Changing the name of this street will not have an effect on the environment; thus, the County has deemed this does not meet the definition of a "project" under CEQA and no environmental impacts are anticipated to occur.

- Section 15061(b)(3) - General Rule "Common Sense" Exemption. With certainty, there is no possibility that the proposed project may have a significant effect on the environment. The renaming of a street will not require any construction activities, change the use or intensity of the existing site to create a physical environmental impact, and would not lead to any direct or reasonably foreseeable indirect physical environmental impacts. Therefore, in no way would changing the name of a street have the potential to cause a significant environmental impact and the vacation is exempt from further CEQA analysis.

- Section 15060(c) – for purposes of analysis under CEQA, changing the name of a street is not a “project” under CEQA pursuant to Section 15060(c). An action by a public agency is only a “project” subject to CEQA if the action might result in a physical change in the environment. Based upon a review of the whole action undertaken, supported, or authorized by the County, in no way will changing the name of a street increase the use of the site, result in increased development or construction impacts, or lead to any direct, indirect, or cumulative physical environmental impacts.

Based upon the identified exemptions above, the County of Riverside hereby concludes that no physical environmental impacts are anticipated to occur and the project as proposed is exempt under CEQA. No further environmental analysis is warranted.
