#### BACKGROUND:

#### Summary

RUHS-BH operates a continuum of care system that consists of County-operated and contracted service providers delivering a variety of mental health treatment services within each geographic region of Riverside County.

Indio Behavioral Health, LLC is seeking LPS (5150) designation for the Coachella Valley Behavioral Health Hospital to provide acute mental health services for individuals involuntarily detained under the California Welfare and Institutions Code, Section 5150. The designation of Coachella Valley Behavioral Health will provide eighty (80) additional acute care hospitalization beds, of those twenty (20) will be dedicated to adolescents, for Riverside County residents with severe mental illness who require a 5150 designated facility for continued medical care and mental health treatment.

Therefore, RUHS-BH is requesting Board approval to designate Coachella Valley Behavioral Health to operate the facility as an LPS (5150) 72-hour treatment and evaluation site and to authorize the Director of RUHS-BH to submit the LPS designation request to DHCS.
