BACKGROUND:

<u>Summary</u>

By Minute Order dated March 8, 2022 (agenda item 3.22) the Board of Supervisors authorized the Clerk of the Board to advertise for the construction of Elm Street Protective Concrete Slab Project. Bids for the project were received in the office of the Director of Transportation at 2:00 PM, Wednesday, March 30, 2022. Four bids were received, ranging from \$464,300 to \$763,930. The Engineer's estimate prepared by Transportation Department for this project was \$476,700.

After bid opening, an existing water pipeline owned by the Morongo Band of Mission Indians (MBMI) was found to be in conflict with the project's original design and a redesign of the project was necessary. The Transportation Department considered it to be in the best interest of the County to reject all bids and change the concrete slab design to avoid conflicts. The County expressly reserved the right, within the approved bid documents, to reject all bids if it is in the best interest of the County.

The proposed updated project includes construction of a protective reinforced concrete slab over the Colorado River Aqueduct (CRA) located beneath Elm Street between approximately 1,500 feet north of Adele Avenue to 1,900 feet north of Adele Avenue in the community of Cabazon.

Elm Street is classified as a Collector road in the County of Riverside's General Plan. Elm Street is a two-lane road and currently ranges from 24-25 feet wide. A protective concrete slab is needed due to the importance of the CRA supplying water to communities and the limited soil cover over the CRA. Mainly, the work will consist of constructing a two-foot-thick protective concrete slab supported by spread footings reinforced with steel bars.

Additional improvements include constructing a widened asphalt concrete approach section, construction of a concrete drainage swale, reconstructing the asphalt concrete pavement and driveway, shoulder backing and grading, utility adjustments, placement of traffic striping, placement of signs, and other associated work.

The submitted plans and specifications have been approved as to form by County Counsel.

The bid documents include the following bid schedule of work:

Base Bid Schedule: Elm Street Protective Concrete Slab

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid for the sum of all bid schedules.

Environmental Findings

The proposed project is exempt from CEQA under Section 15301 (c) – Existing Facilities exemption because the Elm Street protective concrete slab does not create additional traffic lanes and involves negligible or no expansion of existing or former use of the existing roadways and associated facilities. Clerk of the Board of Supervisors will file the Notice of Exemption with the County Clerk and the State Clearinghouse for posting within five (5) working days after Board approval.

Impact on Citizens and Businesses

The purpose of this project is to provide a protective cover over the CRA which provides water services to numerous communities. The protective slab is needed due to the existing limited soil cover and lack of protection over the CRA.

The work is scheduled to begin in summer 2025. The work will include a fourteen-calendar day full-closure on Elm Street with 24-hour shifts to excavate, grade, form, place rebar, pour concrete, cure concrete, and any other associated work to construct the protective concrete slab. Traffic will be detoured through Broadway Street and Esperanza Avenue for commuters traveling to and from the community of homes to the south of Elm Street. The remaining work will be phased to keep the road open, although reduced to a single lane at times, during construction and will take approximately five weeks to complete.

SUPPLEMENTAL: Additional Fiscal Information

The construction contract is estimated to cost approximately \$749,160. The proposed improvements will be funded with Gas Tax/HUTA.

ENVIRONMENTAL ANALYSIS:

Temporary construction easements may be required for the proposed improvements.

A drainage easement over the CRA is needed for this project. The project improvements will not be within the existing footprint of the roadway and will modify the existing roadway profile.

This project is subject to compliance with the County WRMSHCP. In accordance with Section 7 of the Western Riverside County MSHCP, necessary operation and maintenance along existing roadways are considered a covered activity outside of cell criteria areas. This project is considered

to be an operation and maintenance activity; therefore, it is a covered activity under the Western Riverside County MSHCP.

If tree and/or vegetation removal takes place during the migratory bird breeding season (February 1st – August 31st), a preconstruction nesting survey will be conducted pursuant to the Migratory Bird Treaty Act.

The County of Riverside Transportation Department has found that the above-described project is exempt from the provisions of the California Environmental Quality Act (CEQA), based on the following:

Section 15301 (c) – Existing Facilities – The project proposes to construct a protective reinforced concrete slab over the Colorado River Adequate (CRA) located beneath Elm Street. The project in its entirety is consistent with Section 15301(c) because it does not create additional traffic lanes and involves no expansion of use of the existing roadway and associated facilities.




