**BACKGROUND:**

In accordance with State Assembly Bill No. 2022, effective January 1, 2025, the term "squaw" must be removed from all geographic features and place names in California. In compliance with this mandate, the County of Riverside, in consultation with the California Advisory Committee on Geographic Names (CACGN), has designated Púwish Court, Túket Court, or Túchill Court (Private Street) as potential replacement names for Sq\_\_\_ Peak Court (Private Street).

Sq\_\_\_ Peak Court is a privately maintained road located in the Lake Riverside area of unincorporated Riverside County. This road is dedicated for public use but not accepted for maintenance, and seven properties are currently addressed with this street name. Riverside County Information Technology GIS Addressing has reviewed the request and confirmed that there are no conflicts with the proposed new names. Pursuant to the California Environmental Quality Act (CEQA), the project was deemed to either not be a project under Section 15060 or exempt under CEQA under Section 15061(b)(3), General Rule "Common Sense" Exemption, of the State CEQA Guidelines. See the attached Notice of Exemption for detailed analysis.

To ensure compliance with AB 2022, the County conducted mandatory consultation meetings with Tribal Nations and CACGN. Fourteen Tribal Nations were contacted via email, phone, and certified mail. Three tribes—Cahuilla Band of Mission Indians, Soboba Band of Luiseno Indians, and Pala Band of Mission Indians—responded and participated in two virtual consultation meetings held on May 15, 2024, and June 6, 2024. These meetings were required under AB 2022 to ensure the renaming process was inclusive and culturally appropriate.

During the tribal consultations, three culturally significant names were recommended as replacement options. Each option includes the ancestral name and its English equivalent:

**Púwish Court** (Roadrunner)

**Túket Court** (Bobcat)

**Túchill Court** (Hummingbird)

The goal of this renaming effort, consistent with AB 2022, is to use the ancestral name to honor and recognize the cultural heritage, languages, and traditions of the region's indigenous communities.

These recommendations were submitted to CACGN on July 1, 2024, and reviewed during a mandatory public meeting on October 1, 2024, as stipulated by AB 2022. CACGN approved the tribes' preferred name, Púwish Court, as the replacement.

On Tuesday, January 14, 2025, members of the Lake Riverside Estates community expressed to the Board of Supervisor's their opposition to the preferred name, Púwish Court.

As a result, the Transportation and Land Management Agency/Transportation revised Resolution No. 2025-017 to allow for the option to choose one of three options approved by CACGN which are as follows: Púwish Court, Túket Court, or Túchill Court.

RCIT-GIS will assist the impacted residents with changing their addresses and updating the United States Postal Service and any public utility companies that service that community.

The Transportation Department recommends approval of this item.

County Counsel has approved resolution Number 2025-040 as to form.

**Impact on Residents and Businesses**

There are currently seven properties addressed with Sq\_\_\_\_ Peak Court (Private Street).

This street name change will have no impact on local businesses.

**Additional Fiscal Information**

All fees are paid by the Gas Tax. There is no General Fund obligation.

## NOTICE OF EXEMPTION

**Exempt Status:** California Environmental Quality Act (CEQA) Guidelines, Section 15061(b)(3), General Rule "Common Sense" Exemption. Not a "project" as defined under State CEQA Guidelines, Section 15060(c).

**Reasons Why Project is Exempt:** Changing the name of a street has been determined to not be a "project" as defined under State CEQA Guidelines section 15060(c). However, even if it was determined to be a project under CEQA for analysis purposes, the project is exempt from the provisions of CEQA specifically by the State CEQA Guidelines as identified below. The renaming of the existing roadway will not result in any specific or general exceptions to the use of the categorical exemption as detailed under State CEQA Guidelines Section 15300.2. The project will not cause any impacts to scenic resources, historic resources, or unique sensitive environments. Further, no unusual circumstances or potential cumulative impacts would occur that may reasonably create an environmental impact. Changing the name of this street will not have an effect on the environment; thus, the County has deemed this does not meet the definition of a "project" under CEQA and no environmental impacts are anticipated to occur.

- Section 15061(b)(3) - General Rule "Common Sense" Exemption. With certainty, there is no possibility that the proposed project may have a significant effect on the environment. The renaming of a street will not require any construction activities, change the use or intensity of the existing site to create a physical environmental impact, and would not lead to any direct or reasonably foreseeable indirect physical environmental impacts. Therefore, in no way would changing the name of a street have the potential to cause a significant environmental impact and the vacation is exempt from further CEQA analysis.

- Section 15060(c) – for purposes of analysis under CEQA, changing the name of a street is not a “project” under CEQA pursuant to Section 15060(c). An action by a public agency is only a “project” subject to CEQA if the action might result in a physical change in the environment. Based upon a review of the whole action undertaken, supported, or authorized by the County, in no way will changing the name of a street increase the use of the site, result in increased development or construction impacts, or lead to any direct, indirect, or cumulative physical environmental impacts.

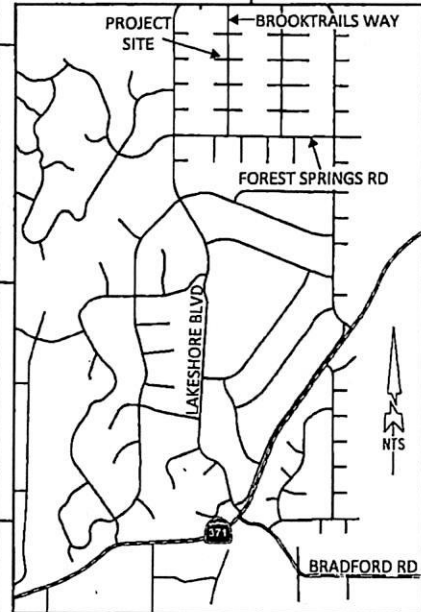

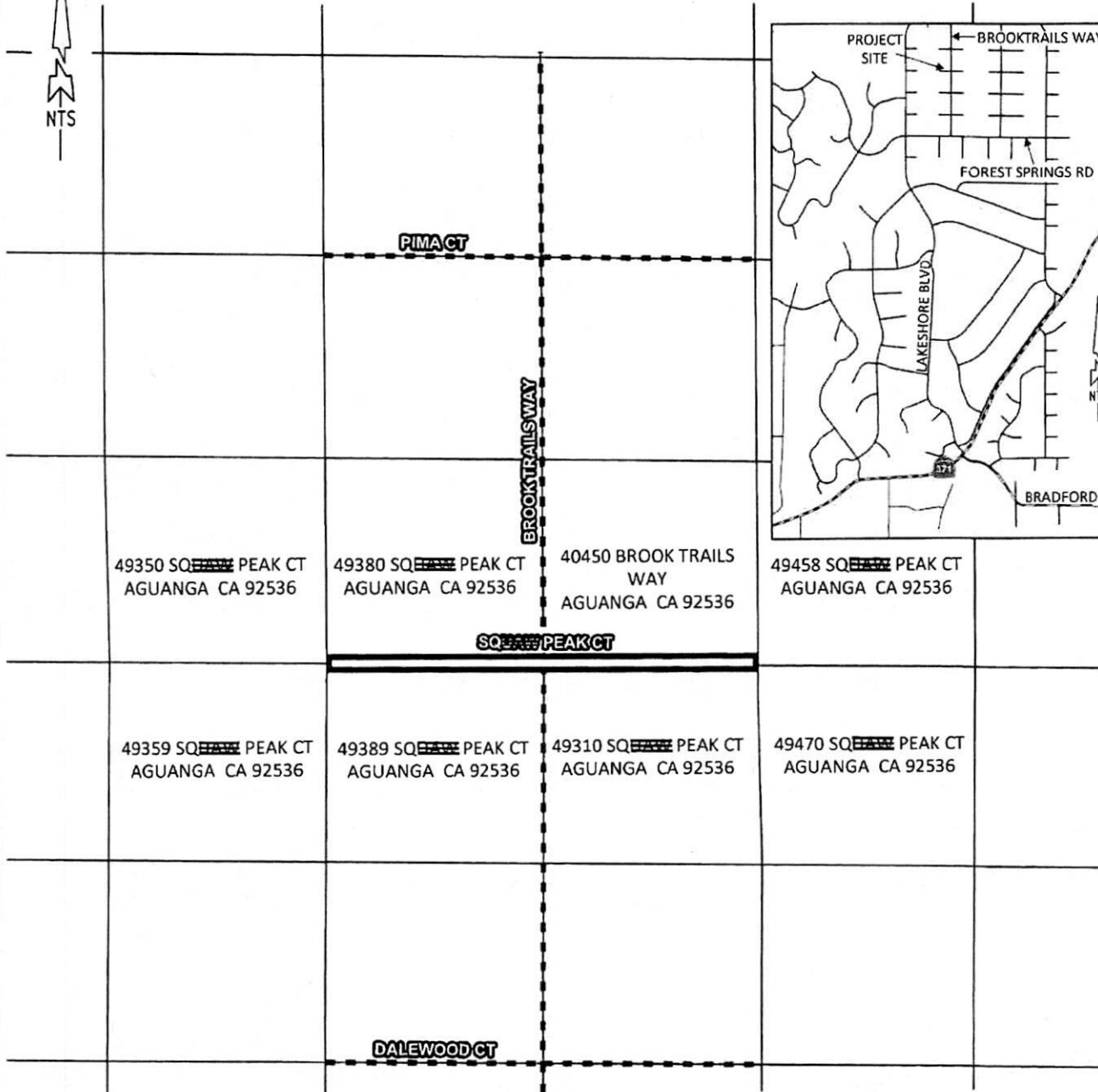
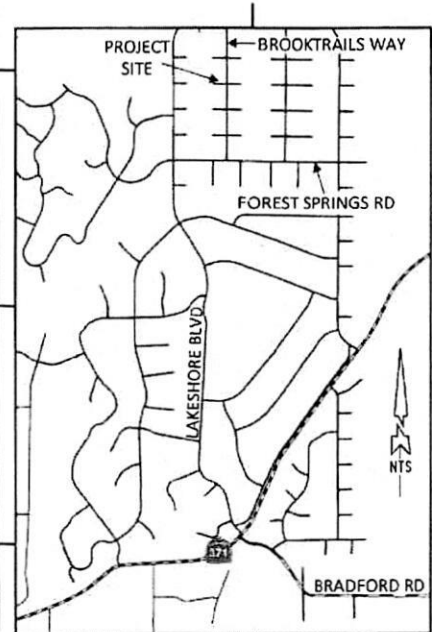

### Power Point Presentations/Printed Material:

Speakers who intend to conduct a formalized Power Point presentation or provide printed material must notify the Clerk of the Board's Office by 12 noon on the Monday preceding the Tuesday Board meeting, ensuring that the Clerk's Office has sufficient copies of all printed materials and at least one (1) copy of the Power Point CD. Copies of printed material given to the Clerk (by Monday noon deadline) will be provided to each Supervisor. If you have the need to use the overhead "Elmo" projector at the Board meeting, please ensure your material is clear and with proper contrast, notifying the Clerk well ahead of the meeting, of your intent to use the Elmo. Speakers are prohibited from bringing signs, placards, or posters into the hearing room.

### Individual Speaker Limits:

When you have 30 seconds remaining, the "yellow" light will begin flash, indicating you must quickly wrap up your comments. Your time is up when the "red" light flashes. The Chair adheres to a strict three (3) minutes per speaker. ***Note: If you intend to give your time to a "Group/Organized Presentation", please state so clearly at the very bottom of the reverse side of this form.***

### Group/Organized Presentations:

Group/organized presentations with more than one (1) speaker will be limited to nine (9) minutes at the Chair's discretion. The organizer of the presentation will automatically receive the first three (3) minutes, with the remaining six (6) minutes relinquished by other speakers, as requested by them on a completed "Request to Speak" form, and clearly indicated at the front bottom of the form.

### Addressing the Board & Acknowledgement by Chair:

The Chair will determine what order the speakers will address the Board and will call on all speakers in pairs. The first speaker should immediately step to the podium and begin addressing the Board. Dear Members of the Board,

On behalf of my neighbors and fellow residents of Sq\_\_\_ Peak Court, we would like to express our gratitude for your efforts in working with us on renaming our street in honor of the local Cahuilla culture and history. After reviewing the three proposed name options, we, the residents and members of the Lake Riverside Estates Board of Directors, are unanimously in favor of the name:

**Túchill Court**

However, we respectfully request that the spelling be adjusted to omit the accent on the letter "u" (i.e., **Tuchill Court**) for the following reasons:

1. **Legibility of Road Signage:** California road signage typically omits accents for readability (e.g., *Via California*, San Juan Capistrano, accent on the i in Via, and *Malaga*, Dana Point, accent on first a). We ask whether the final signage will include the accent mark, or be simplified for consistency.
2. **Postal Service Considerations:** Special characters may complicate mail delivery. Similar to common address abbreviations (e.g., "Lane" vs. "LN"), the inclusion of an accent could create confusion for the automated functions of the Postal Service.
3. **Accessibility:** Typing special characters on different devices and operating systems can be difficult, especially for those unfamiliar with accented letters. This may lead to misspellings and accessibility issues.

Given these concerns, we ask that the street name be officially recorded as **Tuchill Court** without the accent for better consistency, readability, and ease of use.

We look forward to your decision.

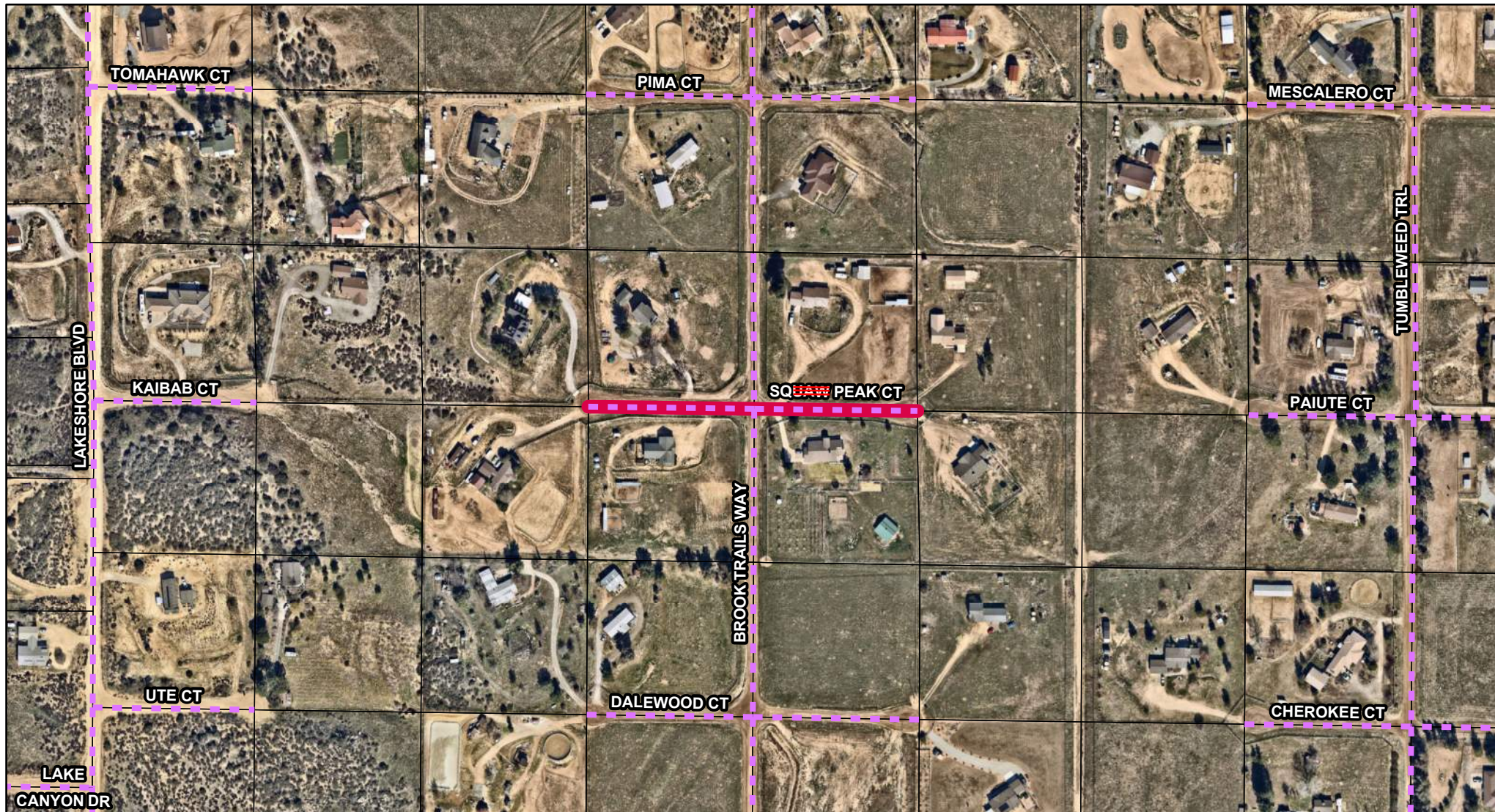

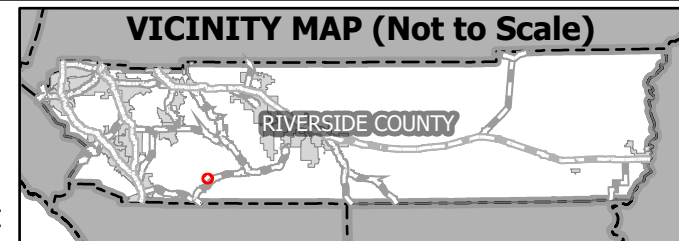
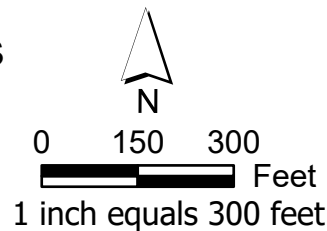
