

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. Habitat for Humanity San Gorgonio Pass Area is receiving Community Improvement Designation Funds (CID) in the amount of \$8,000. Funds will be used to support their Brush with Kindness program.
2. Salt of the Earth Behavioral LLC is receiving Community Improvement Designation Funds (CID) in the amount of \$1,500. Funds will be used to purchase essential materials for reading and writing, sensory tools, and backpacks in order to deliver effective care.
3. Valley View Aquatics Booster is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funds will be used to purchase lockers for the boy's and girl's bathroom on the pool deck.
