Community Improvement Designation funds will be given to the following organizations:

 Camp del Corazon- \$3,000- The funds will be used to support the "DAVI Annual Golf Classic," a fundraiser that helps children with congenital heart defects attend a specialized camp in which participants will have access to a dedicated medical team.

- 2. **Riverside Law Enforcement Appreciation Committee**-\$2,500- The funding will be used to support the annual appreciation awards ceremony, which recognizes volunteers, law enforcement agencies, and citizens who serve Riverside County.
- Rock Your Red-\$3,000 The funding will support the "Rock Your Red" event, an educational program where participants will hear from a panel of cardiologists, stroke specialists, and nurses, and learn about cardiac disease and its warning signs.
- 4. City of Temecula-\$4,000-The funding will be used to support the City's annual "Special Games," an event that allows athletics of all ages with disabilities to participate in non-competitive games, and an award ceremony.
- 5. Soroptimist International-San Jacinto-Hemet Valley-\$1,000- The funds will be used to support the "Dream It, Be It, Girl Power Conference." This day-long event provides teen girls with the opportunity to listen to motivational speakers and to learn about leadership and various professions.
- 6. Voices for Children-\$20,000- The funds will be used to support the Court Appointed Special Advocate (CASA) Program, which pairs foster care youth with a dedicated adult volunteer to advocate for his or her best interest.
- Rotary Club of Menifee-\$2,500- The funds will be used to support the annual Rotary Club of Menifee Charity Gala, an event that raises funds for local nonprofits in the City of Menifee and for military veterans.
- 8. Oak Grove Institute Foundation, Inc- \$2,500- The funds will be used to support the "A Day in Her Shoes" event, which provides mentorship and career guidance to women in fields such as culinary arts, real estate, business, and non-profit organizations.
- Friends of Valley-Wide Foundation- \$2,500-The funding will be used to provide recreational park improvements in the East Hemet, French Valley, Winchester, and Valle Vista areas.
- California Family Life Center- \$2,500-The funding will be used to provide basic needs such as food, clothing, utilities, and case management services to abused victims.
