Pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, commencing with Section 53311 of the California Government Code (the "Government Code"), June 4, 2024, the Board of Supervisors (the "Board of Supervisors") of the County of Riverside adopted Resolution No. 2024-113, stating its intention to establish a community facilities district proposed to be named Community Facilities District No. 24-1M (Sunstone) of the County of Riverside (the "District"), and to authorize the levy of special taxes to fund, pay for, and finance authorized maintenance of landscaping, lighting, traffic signal, drainage, and graffill abatement (the "Services") and to pay expenses incidental thereto and incidental to the levy and collection of the special taxes are needed to fund the Services.

Ordinance No. 991 authorizes the levy of special taxes within the District at the rate and in accordance with the method of apportionment approved by the voters at an election held on July 9, 2024, regarding the proposed levy of special taxes. Ordinance No 991 provides that the Board of Supervisors, as the legislative body of the District, is authorized and directed each fiscal year to determine or cause to be determined the specific special tax rate and amount to be levied for the next ensuing fiscal year for each parcel of real property within the District. The special tax revenues shall be used to fund, pay for, and finance the Services and shall be levied so long as special taxes are needed to fund such Services. In addition, the special tax revenue may be used to replenish a reserve fund for the District, to pay the costs of administering the District, and fund the cost of collecting and administering the special tax. Ordinance No. 991 provides that the special taxes may be collected on the secured property tax roll in the same manner as ordinary ad valorem taxes and that the special taxes shall have the same lien priority, and be sublect to the same penalties and
