BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

- Michelle's Place Cancer Resource Center- \$10,000- The funds will be used to support Michelle's Place Behavioral Health program. This program provides 150 cancer patients and their families with behavioral health counseling sessions. Each Patient will receive 10 sessions, and 5 family/children support sessions.
- 2. **MilVet**-\$1,000- The funding will support MilVet's annual Honors fundraiser, which raises money for the organization's emergency veteran assistance program
- Riverside County Office of Education-\$2,500 —The funding will support the 2025 Riverside County State of Education, an event that brings together the public, educators, and students to showcase the county's innovative educational ecosystem.
- 4. Riverside County District Attorney's Office-Division of Victim Services \$5,000-The funding will be utilized to support the National Crime Victims' Rights Week, an annual event, that honors and brings tribute to victims of crime and their families through the Vigil and Memorial Wall.
- 5. **Temecula Valley Chamber of Commerce**-\$2,750- The funds will be used to support the 59th Annual Award Gala, an event that honors local business owners, charitable organizations, and individuals for their exceptional contributions to the community.
- 6. **Nighthawk Marching Band Booster-** \$5,000-The funding will be used to purchase new equipment to help with fundraising efforts for the Murrieta Valley High School Marching Band.
