

3. Community Center for Healthy Minds is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funding will be used to support their programs that help individuals with domestic violence.
4. Freedom Writers Foundation is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funding will be used to support student assemblies and engagement workshops.

7. Pop Warner Little Scholars Inc. is receiving Community Improvement Designation Funds (CID) in the amount of \$2,500. Funding will be used to support the cost of uniforms, equipment, and facility rental expenses.
