C.E.O. RECOMMENDATION: Approve BACKGROUND: Summary

On September 17, 2024, Item 3.12, the Board of Supervisors (Board) approved the County Administrative Center (CAC) 3rd Floor Mezzanine Roof Replacement Project (Project) located at 4080 Lemon St., Riverside, California, 92501 and the emergency procurement Purchase Orders with Best Contracting Services, Inc. in the amount of \$569,995, and Mesa Energy Systems, Inc., dba EMCOR Services Mesa Energy, in the amount of \$40,034. The cumulative total cost of the Project was \$610,029; and ensured the proper mitigation and restoration repairs to the mezzanine roof of the CAC building that has now been fully restored to safe and normal operational conditions.

Best Contracting Services, Inc. and Mesa Energy Systems, Inc. have substantially completed their portions of the work which has been inspected and found to comply with the terms of the contract. This Board action is to record the Notice of Completion as per the contract terms and applicable law.

Impact on Residents and Businesses

The CAC 3rd Floor Mezzanine Emergency Roof Replacement Project will ensure that the 3rd floor of the CAC facility is maintained and hazard free, thus providing a safe environment for both visitors and employees that occupy this floor.




