

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Assistance League of Riverside** is a volunteer led organization that is dedicated to clothing, comforting, and educating the children and young adults in our community. The proposed funding in the amount of **\$2,500** will be used to sponsor an annual spring event fundraiser that is scheduled on March 29, 2025, for the children they serve in the Cities of Riverside, Jurupa Valley, and Perris.
2. **Big Brothers Big Sisters of Orange County and Inland Empire's** mission is to create and support mentoring relationships that ignite the power and promise of the next generation. Their program is effective in creating opportunities for marginalized youth. The proposed funding in the amount of **\$10,000** will be used to support two signature programs including the Next Gen Leadership Summit on March 8, 2025, and the 2nd Annual Mental Health Summit on June 14, 2025.
3. **Inland Empire Contemporary Ballet** provides educational and performance opportunities in both classical and contemporary ballet to dancers from underserved communities. The proposed funding in the amount of **\$3,000** will be used for scholarships and performance opportunities for students from the Riverside area.
4. **Fair Housing Council of Riverside County** strives to ensure that all individuals will live free from unlawful housing practices and discrimination. This non-profit organization fights to protect the housing rights of all individuals. The proposed funding in the amount of **\$5,000** will sponsors the 7th Annual Housing Conference scheduled for April 16, 2025, which will address issues identified that affect housing choice for residents of Riverside County. The Conference will bring together community nonprofits, government officials, lenders, builders, developers, policymakers, housing providers, realtors, and community leaders to discuss the future of housing in the Inland Empire.
