

BACKGROUND/APPOINTEE INFORMATION:

Supervisor Jose Medina recommends the appointment of George L. Ruiz to the Flood Control and Water Conservation District Commission, Zone 1. Mr. Ruiz was employed at the Riverside County Flood Control and Water Conservation District (District) for forty-eight years. During his tenure, he was employed in the District's Maintenance and Operations division. In that time, he acquired a variety of skills ranging from heavy equipment operator to Engineering Technician at the time of his retirement. He was most recently tasked with being the District's liaison in dealing with homeless issues in cooperation with cities and law enforcement within the County.

Mr. Ruiz has resided in the City of Jurupa Valley for sixty-two years. He was appointed to the Jurupa Valley Planning Commission shortly after the City's incorporation for eight years. He currently serves as a member and Chair of the City's Community Development Advisory Committee.
