### BACKGROUND/APPOINTEE INFORMATION:

Supervisor Jose Medina recommends the appointment of Marquis Palmer to the Veteran Advisory Committee. Mr. Palmer is a Marine Veteran who has many years of experience, serving the unhoused population which includes veterans in the region.
