**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

- Riverside Arts Academy (RAA) has provided high-quality, accessible music education to Riverside's youth since 2012. Their after-school music program (RAAMP) is based at the Cesar Chavez Community Center in the Riverside Eastside neighborhood. This program is geared towards students of all skill levels and ages (7-17), the program aims to foster cultural enrichment, creativity, and social-emotional development through highquality music instruction. The proposed funding in the amount of \$5,000 will support the year-round tuition of a few students in the Riverside and Jurupa Valley School District areas.
- 2. Civil Rights Institute Inland Southern California (CRIISC) inspires people of all ages through lifting the ongoing and historic civil rights stories of the region, fostering community advocacy, and building the champions of tomorrow. Their vision is to connect people from all walks of life through stories, sharing of information, and personal relationships to make Inland Southern California a center of civil rights and social justice. The proposed funding in the amount of \$70,000 will be used to develop an Ethnic Studies Resource Center wherein CRIISC will create a local ethnic studies high school curriculum, develop a suite of online resources, enter classrooms with engaging activities, and host events for local teachers in Riverside County.
- 3. Riverside LGBTQ+ Pride Inc's mission is to inspire, educate, commemorate, celebrate and illuminate our diverse Riverside community through public service and public events. They also serve those in need by connecting community members to resources that help them to thrive, educate others through programs that help them grow, and events that commemorate and illuminate those who need help to shine. The proposed funding of \$5,000 will be used to sponsor the 3rd Annual Riverside Pride Festival, taking place on May 10,2025, at White Park in Downtown Riverside.
- 4. Riverside Community Services Foundation (RCSF) was established in 2007 and serves as the charitable arm of the City of Riverside's Parks, Recreation, and Community Services Department. RCSF supports programs in arts and culture, environmental stewardship, youth initiatives, senior activities, therapeutic programs, and youth scholarships, aiming to enhance the quality of life for all Riverside residents. The proposed funding of \$5,000 will be used to sponsor 15<sup>th</sup> Annual Young Men's Conference "Reach for your Potential," scheduled in March 2025, at the Bourns Technology Center, in Riverside. The program will serve 200 male students from Riverside Unified School District (RUSD) and Alvord Unified School District (AUSD), ages 12-18, providing them with valuable mentorship and development opportunities.
- Riverside County Department of Animal Services will use the \$12,000 grant funds to provide four Mobile Spay & Neuter and Vaccine Clinics in the Good Hope and Mead Valley communities of the First District.




