BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. California Coverage & Health Initiatives' (CCHI) is a statewide, non-profit membership association, comprised of community-based organizations (CBOs) and local government partners throughout California who employ Community Health Workers (CHWs), enrollment counselors, and Health Access Assisters (HAAs) who offer culturally and linguistically appropriate navigation services to help clients in need understand and utilize their health coverage. Each year, CCHI hosts its Membership Meeting, Champions for Coverage Awards, and Day at the Capitol event to honor local leaders within our network who make a significant difference in the lives of Californians. CID funds will contribute to the awards for honorees, accessible promotional materials and translation services to ensure a well-organized and inclusive event.
- 2. The Codex Creation Committee hosts the annual Mobius Conference, which provides spaces for intellectual exchange on important revolving topics. This event brings together community leaders, heads of industry, and students for diverse programming designed to empower and educate. The event will be held on April 16-17 at four different sites across the Coachella Valley. CID funds will support production, transportation, food and beverage.
- 3. The Catholic Church in Mecca Our Lady of Guadalupe is not only a center of faith, but also a fundamental pillar in the community and cultural life of thousands of families, mostly Purépecha descent. The Church is working on launching music school for children and young people to provide learning, recreation and emotional development in a community facing significant social challenges. The initial stage of this program will serve 40 children and young people from low-income families at low-cost. The program includes instrument classes, vocal training and choir sessions, traditional music workshops to preserve cultural heritage and group practice sessions. CID funds will directly support the Mecca Community Music School, covering the operation of the music school four days a week.
