BACKGROUND:

Summary

On August 30, 2022, Item 3.54, the Board of Supervisors (Board) approved the purchase of new Enterprise Wi-Fi Network equipment for County owned and leased facilities throughout Riverside County. The new Wi-Fi equipment will provide enhanced critical security and operational improvements to further safeguard the County's IT network, extend access and take advantage of industry advancements.

On April 4, 2023, Item 3.9, the Board approved in-principle and preliminary project budget in the amount of \$872,588 for the Riverside University Health System Facilities Enterprise Wireless Access Point Replacement Project (Project). On April 26, 2022, Item 3.10, the Board approved the Construction Contract for Job Order Contract No. 017 between the County of Riverside (County) and Horizons Construction Company International, Inc. (Horizons). Pursuant to the contract, one job order was issued for the installation of the new Enterprise Wi-Fi Network equipment at RUHS facilities which encompassed facilities in Moreno Valley, California and at 9990 County Farm Road, in Riverside, California, in compliance with the Department of Health Care Access and Information (HCAI) requirements, in the amount of \$625,751.

Horizons has successfully completed the work, and the Project has been inspected and found to comply with the contract, safety and HCAI requirements. This Board action will release the

undisputed contract retention funds in the amount of \$31,288 to Horizons after the Notice of Completion has been recorded per the contract terms and applicable law.

The RUHS Facilities Enterprise Wireless Access Point Project will provide enhanced critical security and operational improvements to further safeguard the County's IT network, extend access and take advantage of industry advancements.
