# BACKGROUND:

## Summary

On April 13, 2021 (Agenda Item 12.1), the Board awarded Tetra Tech BAS, Inc., a three-year contract for Construction of Landfill Gas Collection System (GCS) Components at the Badlands, Corona, Lamb Canyon, and Mecca II Sanitary Landfills and as needed Perimeter Probe Installation at all Department Landfills.

Tetra Tech BAS, Inc. satisfactorily completed the Lamb Canyon Landfill GCS Expansion Phase 4 Project at a cost of \$91,799.50 and staff recommends approval of the Notice of Completion. The Notice of Completion is for completed work associated with a Notice to Proceed, dated November 21, 2024, at the Lamb Canyon Landfill.

## Impact on Residents and Businesses

This contract ensures the Department's ability to efficiently collect the landfill gas generated at the Department's landfills and to monitor potential landfill gas migration at Department landfills to maintain compliance with air quality regulations.

This is an administrative action to file the Notice of Completion for the subject construction project. No funds are being requested.

#### Contract History and Price Reasonableness

On April 13, 2021 (Agenda Item 12.1), the Board awarded Tetra Tech BAS, Inc., a three-year contract for a total amount of \$2,416,959. Change Order No. 1 was executed by the Department, as the Board of Supervisors' designee, and Tetra Tech BAS, Inc., on April 13, 2024 to extend the term of the contract until December 31, 2024. Under this contract to date, a total of 16 construction projects have been completed. A contract summary of the cost expenditures is summarized below.


