BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- 1. Girl Scouts of San Gorgonio Council develop girls critical thinking, community development, project management skills, and more to create well-rounded community leaders among other 21st Century skills. The girls meet with mentors and committee members at the Riverside location to work on their Gold Award. The \$5,000 will sponsor the Gold Award Gala, that is scheduled on June 7, 2025, at the Life Arts Center in Riverside. Funding will also provide support to Girl Scouts that reside in the First District.
- 2. Riverside County Department of Public Social Services Adult Services Division provides programs, services, and protection for elder adults from abuse and or neglect and provides access to health care coverage to low-income individuals and families. The \$4,000 funds will be used to sponsor the 2025 Elder and Dependent Adult Abuse Symposium on June 6, 2025.
- 3. Jurupa Unified School District Parent Involvement & Community Outreach (PICO) Department, support families and students through community engagement, resource connection, and direct services. The \$2,000 is a sponsorship for their 4th Annual Day of the Child 2025 Resource Fair event on April 16, 2025.
- 4. Construction Industry Education Foundation (CIEF) works to introduce and engage high school students and young adults to the rewarding careers available in the building environment. CIEF will serve more than 14,000 students throughout their program and award more than \$145,000 in academic and summer program scholarships. This \$3,500 sponsorship is to sponsorship Ramona High School students in the 2025 Southern California design Build Competition being held on April 9–10, 2025, in Huntington Beach, CA.
- 5. Love and Nurture Initiative, is committed to improving the lives of underrepresented and marginalized individuals by providing services focused on mental and emotional well-being, empowering them with resources and tools to thrive in their communities and families. This \$12,000 grant is to coordinate the Light in the Storm: Community Emergency Initiative in the Perris and Mead Valley areas by raising awareness and providing the necessary resources to navigate emergency situations.
- 6. Riverside University Health System Foundation (RUHSF), is dedicated to the mission of RUHS by providing superior quality health care to Riverside County residents with a special focus on individuals and populations in need. This \$5,000 grant is to sponsor "April is National Child Abuse Prevention Month" activities such as the 2025 Pinwheels for Prevention Celebration of Hope event scheduled for April 24, 2025.

- 7. Riverside County District Attorney's Office Division of Victim Services' mission is to empower victims and witnesses of crime through advocacy and support services while promoting successful prosecution. This Department works with many organizations to organize the National Crime Victims' Rights Week and the commemoration of victims' names on the Memorial Wall is for all victims of crime and their families across Riverside County and therefore, the \$4,000 grant will support these events.
- 8. California Family Life Center, raises funding to assist with gaps in funding, including counseling, food, shelter, and clothing to families in need. This \$700 sponsorship will support the logistics and operating costs behind "Our Family, Our Future" benefit dinner and silent auction.
- **9.** California Citrus State Historic Park Nonprofit Management Corporation aims to support and operate the maintenance of the California Citrus State Historic Park's groves, citrus production, the Sunkist Center, amphitheater, group picnic event areas, and educational and interpretive programs. This \$5,000 grant will be a sponsorship for the 3rd Annual Citrus Festival on April 5, 2025, at the California Citrus State Historic Park, in the City of Riverside.
