#### BACKGROUND:

#### Summary

The project proposes to resurface an approximately 3.6 miles segment of Acacia Avenue between 200-feet east of San Jacinto Street and 275-feet east of Jared Lane in the community of East Hemet.

By Minute Order dated June 4, 2024 (agenda item 3.49), the Board of Supervisors approved an exemption from the "or equal" substitution requirements per Public Contract Code Section 3400(c)(1) to use the HyRAP® Hot Mix Asphalt product, and authorized the Clerk of the Board to advertise for the construction of Acacia Avenue Resurfacing Project. On the original bids due date of Wednesday, June 26, 2024, no bids for the project were received in the office of the Director of Transportation.

The original project design included the installation of a proprietary hot mix asphalt product that uses 100% reclaimed asphalt pavement called HyRAP Hot Mix Asphalt (HyRAP HMA). Manhole Adjusting Inc. (MAI) is the only company that produces and sells HyRAP HMA in Southern California, so bidders were instructed to subcontract MAI for procurement and installation of HyRAP HMA.

Because zero bids were received, Transportation Department has re-evaluated the project, and has adjusted the plans and bid specifications to attract more bidders. The Transportation

Department would like to use Acacia as a Pilot Project to asses the asphalt mix, installation process, cost, structural stability, rideability, and longevity of the HyRAP HMA material; however, Transportation Department considers it to be in the best interest of the County to limit the use of HyRAP HMA to just one segment of Acacia Avenue between Yale Street and Meridian Street, and incorporate the use of Rubberized Hot Mix Asphalt overlay and conventional Hot Mix Asphalt on the remaining segments of the Acacia Avenue project to allow a direct comparison for the HyRAP HMA's performance. Pursuant to Public Contract Code (PCC) section 3400(c)(1), it is necessary to specify the use of HyRAP HMA, without permitting equal substitutions, to determine the product's suitability for future use. Transportation Department recommended findings for HyRAP HMA are included in "Attachment 1" and upon adoption by the Board will be incorporated to the Notice to Bidders in accordance with PCC section 3400(c)(1).

Acacia Avenue is a two-lane facility with a road width of 28 to 42 feet and is currently classified as a local road in the circulation element of the County of Riverside General Plan. The area in the immediate vicinity is residential with single family dwellings.

Roadway resurfacing is needed due to the deteriorated pavement conditions. Mainly, the proposed resurfacing project consists of overlaying existing pavement with Rubberized Hot Mix Asphalt (RHMA). Additional treatments at various segments of roadway include removing the existing asphalt concrete pavement and underlying material plans and placing back Hot Mix Asphalt (HMA) pavement and RHMA. At Acacia Avenue intersections with main streets, transition treatment will consist of grinding down a portion of the existing asphalt concrete pavement followed by overlaying back with RHMA.

Additional improvements include construction of asphalt concrete dike, construction of asphalt concrete driveways, placement of safety edge and shoulder backing to protect the outside edge of pavement, safety features include placing of thermoplastic pavement marking, roadside signs, the traffic signals at the intersections of Yale Street and Stanford Street will be updated from a loop detection system to a video detection system and other associated work.

The submitted plans and specifications have been approved as to form by County Counsel.

The bid documents include the following bid schedules of work:

Base Bid Schedule 1: Acacia Avenue Resurfacing Project
Alternative Bid Schedule 1: Frontier Manhole Adjustments

Alternative Bid Schedule 2: Eastern Municipal Water District (EMWD) Manhole Adjustments

The adjustment of the facilities owned by Frontier and EMWD are also included in the bid package as alternative bid schedules. If Frontier and EMWD approve the award of their respective alternative bid schedules, as bid by the apparent low bidder, then the cost for the work will be funded by the utility owner through reimbursement letter Agreement that will be

executed by the Director of Transportation. The Director of Transportation has the authority to sign reimbursement Agreements up to \$100,000 per Minute Order dated November 19, 2019 (Agenda Item 3.25).

The Transportation Department will select the contractor based upon the lowest responsive and responsible bid.

#### **Environmental Findings**

The proposed project is exempt from CEQA under Section 15301 (c) – Existing Facilities exemption because the Acacia Avenue resurfacing project does not create additional traffic lanes and involves negligible or no expansion of existing or former use of the existing roadway and associated facilities.

#### Environmental Benefits of HyRAP HMA

At a time when greenhouse gases (GHG) need to be reduced, HyRAP HMA is anticipated to significantly reduce our carbon footprint. Paving streets with HyRAP HMA limits refining new crude oil. HyRAP HMA reuses the paving grade asphalt oil from old streets (by way of reclaimed asphalt pavement grindings) and incorporates it to pave new streets. Paving streets with HyRAP HMA eliminates the need to mine new sand and rock (commonly referred to as "aggregates"). A typical mining facility produces 23,264 – 93,057 pounds of GHG per day. Paving streets with HyRAP HMA prevents old asphalt grindings from being sent to our local landfills or, sometimes worse, being stored in our communities leading to "black dust" and poor air quality. Paving streets with HyRAP HMA reduces emissions and truck traffic (commonly referred to as vehicle miles traveled or "VMT") generated by hauling traditional hot mix asphalt, and its ingredients, over long distances. HyRAP HMA, can be ground down, reprocessed, and repurposed multiple times over.

#### Impact on Citizens and Businesses

The purpose of this project is to improve existing deteriorated pavement with new HMA and RHMA for the approximate 3.6 miles segment of Acacia Avenue between 200-feet east of San Jacinto Street and 275-feet east of Jared Lane, in the community of East Hemet, to provide the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic.

The work is scheduled to begin in early summer 2025. The work will be phased to keep the road open during construction as much as possible and will take approximately four months to complete.

#### SUPPLEMENTAL:

#### Additional Fiscal Information

The construction contract is estimated to cost approximately \$4,857,782. The County improvements will be funded with Gas Tax/SB-1, Frontier and Eastern Municipal Water District funds.

There are no General Funds used in this project.







#### Transportation Department Recommended Findings for HyRAP HMA

The County of Riverside, Transportation Department makes the following findings under Public Contract Code section 3400(c)(1):

California law, as specified in Assembly Bill 32 (Chapter 488 of the statutes of 2006), and updated in Senate Bill 33 (Chapter 249 of the statutes of 2016) and Assembly Bill 197 (Chapter 250 of the statutes of 2016) requires that emissions return to 1990 levels by 2020 and reach 40 percent below that marker by 2030. The transportation industry is one of the largest contributors to greenhouse gas emissions ("GHGs"). Overall progress notwithstanding, the transportation sector, which includes light duty, medium duty, heavy duty and off-road vehicles, saw a 2 percent increase in emissions in 2016 because of increased fuel consumption according to a state report from CARB dated July 11, 2018 (Release Number 18-37).

All California public agencies must contribute their best efforts to reduce GHGs.

Conventional hot mix asphalt is a combination of virgin aggregate (stone, fines, etc.) and liquid asphalt (oil). Conventional production of hot mix asphalt requires significant mining operations to obtain the required aggregate (usually about 95% of the finished product); and between 5% and 6% of conventional hot mix asphalt is refined oil.

Mining aggregate requires the use of diesel burning heavy equipment. The combustion of 1 gallon of diesel fuel generates approximately 22.4 pounds of Carbon Dioxide. Aggregate mining facilities generate, on average, between 23,264 and 93,057 pounds of GHGs per day. The most efficient mining operations may generate 11.6 million pounds of GHGs from mining aggregate for 1 month of conventional hot mix asphalt for use in California (1 million ton per month x 11.6321 lbs. of GHG per ton). Mining also generates particulate matter, as well as toxic pollutants such as NOX, SOX, ozone, formaldehyde, benzene, and similar organic molecules, all of which cause environmental and health problems.

HyRAP® Hot Mix Asphalt is produced almost entirely using recycled asphalt materials which are currently being landfilled or left in ever growing piles, and a petroleum rejuvenator at only 1.5% by weight of the finished product. This means that there is a reduction of nearly 100% in virgin aggregates and 70% in petroleum products used to produce the product. Significant reductions in pollution generated by transportation of the raw materials will also be achieved through use of the HyRAP® process.

The HyRAP® process has been used in other states but has not been the subject of any comprehensive field tests to determine its suitability for use in California. If field tests of HyRAP® demonstrate that it is equal to or superior to conventional hot mix asphalt in life cycle performance, the use of HyRAP® could provide significant environmental advantages and contributions to the reduction of GHGs.

In order that a field test may be made of the HyRAP® process to determine the product's suitability for future use, only HyRAP® material shall be utilized as the hot mix asphalt material in construction of this project.
