**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

1. The donation to 100 Black Men of the Inland Empire, Inc. (\$2,500.00) will support the 100 BMIE Umoja Scholarship to a deserving student from Norco College. This scholarship helps students invest in their education and supports their aspirations to transfer to 4-year colleges and universities, Historically Black Universities (HBCUs), or private institutions.
2. The donation to Machado Family Giving Inc. (\$4,000.00) will be used for the Smart School Supplies Program, which will provide backpacks and school supplies for students in need throughout the Jurupa Unified School District.
3. The donation to the Jurupa Valley Chamber of Commerce (\$1,100.00) will support the National Day of Prayer in the City of Jurupa Valley, which invites the community to pray for the Nation. First created in 1952 by the United States Congress, it exists to create appropriate materials and mobilize the community.
4. The donation to Corona Life Services DBA Zoi (\$1,500.00) will serve pregnant women and families with services including education, medical services, and resources.
