BACKGROUND:

Summary

The Insurance Commissioner of the State of California has renewed awarded funding under the Disability and Healthcare Insurance Fraud Program for the program period of July 1, 2025 through June 30, 2026.

The Disability and Health Insurance Fraud Grant Program funding is made pursuant to section 1872.85 of the California Insurance Code that requires (a) Every admitted disability insurer or other entity liable for any loss due to health insurance fraud doing business in this state to pay an annual special purpose assessment to be determined by the commissioner, but not to exceed twenty cents (\$0.20) annually for each person in this state covered under an individual or group insurance policy regardless of the situs of the contract or master group policyholder, and regardless of whether the insured has been issued an individual certificate of coverage, and including blanket insurance as defined in Section 10270.2, in order to fund increased investigation and prosecution of fraudulent disability insurance claims (b) The commissioner to distribute funds pursuant to subdivision (a) to district attorneys who are able to show a likely positive outcome that will enhance the prosecution of disability insurance fraud in their jurisdiction based on specific criteria promulgated by the commissioner.

Per California Code of Regulations, Title 10, Section 2698.95 et seq., priority shall be given to those grant applications which, in the determination of the Commissioner, have the potential to have the greatest impact on disability insurance fraud activity. The Riverside District Attorney will use these funds for the purpose of investigation and prosecution of disability and healthcare insurance fraud cases.

The attached resolution No. 2025-073 has been reviewed and approved as to form by County Counsel.

Impact on Residents and Businesses

All costs under this program will be recovered through grant funding.

7 WHEREAS the County of Riverside Board of Supervisors desires to undertake a certain
8 program designated the Disability and Healthcare Insurance Fraud Program to be funded in part
9 from funds made available through California Insurance Code Section 1872.85, California Code
10 of Regulations, Title 10, Section 2698.95 et seq. and administered by the California Department
11 of Insurance; and

12 WHEREAS, the Office of the District Attorney works on behalf of the County to
13 investigate and prosecute disability and healthcare insurance fraud cases.

14 NOW THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED by the Board
15 of Supervisors of the County of Riverside, in regular session assembled on April 08, 2025,
16 located on the first floor of the County Administrative Center, 4080 Lemon Street, Riverside,
17 California, that the Board of Supervisors hereby authorizes the District Attorney of the County of
18 Riverside, or designee, on behalf of the Riverside County Board of Supervisors, to submit the
19 grant proposal to the California Department of Insurance and is authorized to execute on behalf
20 of the Board of Supervisors, the Grant Award Agreement including any extensions or
21 amendments thereof, as approved by County Counsel. This resolution shall be in effect for a
22 three-year period beginning July 01, 2025 and ending June 30, 2028.

23 IT IS AGREED that any liability arising out of the performance of the Grant Award
24 Agreement, including civil court actions for damages, shall be the responsibility of the grant
25 recipient and the authorizing agency. The State of California and the California Department of
26 Insurance disclaim responsibility for any such liability.

27 BE IT FURTHER RESOLVED that the grant funds received hereunder shall not be used
28 to supplant expenditures controlled by this body.


