

**BACKGROUND:**

Community Improvement Designation funds will be given to the following organizations:

1. **Temecula Valley Chamber of Commerce-** \$2,700- The funding will support two programs: (1) the State of the City Address and (2) the Student of the Month Program.
2. **Inland SoCal United Way-** \$ 2,500- The funding will support the Inland SoCal United Way “United for Good” event, which honors local partners and volunteers dedicated to providing resources and services to low-income families.
3. **Reaching New Heights Foundation Inc.-** \$ 5,000 —The funding will be used to support the 9th Annual Ruck Challenge 5K/10K, an event that raises funds to provide mental and physical wellness programs for veterans.
4. **City of Hemet Fire Department-**\$10,000-The funding will be used to support the Girls’ Empowerment Camp, a program that provides attendees with free training in CPR, wildland firefighting, search and rescue, and physical fitness.
5. **Hospice of the Valleys SC-** \$7,000- The funds will be used to support the Senior Assistance Program, which provides free hospice care to disabled seniors.
6. **Shoes That Fit -**\$2,000- The funds will be allocated to provide a pair of shoes to low-income children in the Third District.
7. **Greater Menifee Valley Chamber of Commerce-** \$4,500- The funds will be used to support two events: (1) the Menifee State of the City Address and (2) the Chamber’s 47th Annual Business Awards.
