BACKGROUND:

Summary

Judges in Superior Courts may make motions directing the county to pay for creating a verbatim record in criminal matters, appeals, juvenile proceedings, proceedings to declare a minor free from custody, probate proceedings and some civil matters. Trials have steadily increased as the Courts ramp back-up to prepandemic workloads resulting in increased costs to this budget unit. A shortage of court reporters has also driven up the cost of transcripts, driving expenditures to unprecedented levels. Current projections reflect the need for an additional \$525,000 in appropriation to meet demands for Fiscal Year 2024-25.

Impact on Residents and Businesses

Providing these services allows the County to support attorneys to help meet their constitutionally mandated requirement to deliver an adequate defense.

<u>Additional Fiscal Information</u>

The Executive Office requests \$525,000 from general fund contingency for the current fiscal year as there are not sufficient departmental funds for projected expenditures in Fiscal Year 2024-25.
