

## BACKGROUND:

## Summary 3 8 1

On February 28, 2023 (Item 3.13), the Board of Supervisors (Board) approved the project budget in the amount of \$832,200 for the County Fire Admin Parking Lot Phase I Project, located at 403 East 4<sup>th</sup> Street in Perris, California, 92570. The scope of work included, but was not limited to the following: demolition and installation of new reinforced concrete driveway, steel fencing with motorized gate, installation of two shade structures, outdoor lighting, irrigation system, landscaping, concrete flatwork, and pavers.

On April 26, 2022 (Item 3.10), the Board approved the construction contract for Job Order Contract No. 017. Subsequently, on July 11, 2023 (Item 3.12), the Board approved the construction contract for Job Order Contract No. 018 between the County of Riverside (County) and Horizons Construction Company International, Inc. (Horizons). Pursuant to the contracts, two job orders were issued for parking lot repaving and restriping to Horizons in the cumulative amount of \$397,221.

Horizons has completed the work, and the Project has been inspected and found to comply with the contract and safety requirements. This Board action will accept the Project as complete and release the undisputed contract retention funds in the amount of \$11,168 to Horizons per the contract terms and applicable law.

#### Impact on Residents and Businesses

The County Fire Admin Parking Lot Phase I Project will provide site security improvements and handling of emergency vehicles to allow the Fire Department to provide services to the community in the most cost effective and timely matter.

#### Additional Fiscal Information

All costs associated with this Board action were previously approved on February 28, 2023, (Item 3.13) and are 51% funded by Fire Department General Fund 10000 and 49% funded by Structural Fire Taxes Fund 21000. Retained funds in the amount of \$11,168 are accounted for
