**SUBJECT:** RIVERSIDE UNIVERSITY HEALTH SYSTEM-PUBLIC HEALTH: Authorize the Acceptance of Funding from the California Department of Public Health (CDPH) for Implementation of the Children and Youth with Special Health Care Needs (CYSHN) Innovation Grant for the Period of Performance of July 1, 2025, through June 30, 2030, with the Option to Accept Additional Funding Through June 30, 2035. All Districts [Total Aggregate Award Amount: \$2,328,895; up to \$465,779 in additional funding - 100% Federal]

**RECOMMENDED MOTION:** That the Board of Supervisors:

- Authorize the Acceptance of Funding from the California Department of Public Health (CDPH) for Implementation of the Children and Youth with Special Health Care Needs (CYSHN) Innovation Grant (the Program) in the aggregate amount of \$2,328,895 for the period of performance of July 1, 2025, through June 30, 2030; and
- 2. Authorize the Director of Public Health, or designee, as approved as to form by County Counsel, to sign and execute the Grant Agreement and/or subsequent Amendments to the Grant Agreement from CDPH for CYSHN once it becomes available, including amendments to the compensation provisions that do not exceed the sum total of twenty percent (20%) of the aggregate grant amount; and



# BACKGROUND:

# Summary 5 1 1

The California Department of Public Health (CDPH), Maternal, Child and Adolescent Health (MCAH) Division, has submitted a Notice of Intent to Award to Riverside University Health System - Public Health (RUHS-PH) in the amount of \$2,328,895 through the Children and Youth with Special Health Care Needs (CYSHCN) Innovation Grant. RUHS-PH's MCAH Branch intends to utilize this funding to continue to establish best practices and successful approaches that can be adopted by other local MCAH programs to improve systems that serve CYSHCN and their families. This innovative project will allow RUHS-PH's MCAH Branch to continue their support of interventions that address the broader needs of CYSHCN, create more systems level change, and focuses on a strengths-based resilience-building approach for CYSHCN and their families.

# Impact on Residents and Businesses

This funding will engage families, help build capacity, increase resilience, as well as improving public health systems that serve Children and Youth with Special Health Care Needs and their families throughout Riverside County. The impact of the program will be positive for those residents/clients who participate in the program, who will receive additional social and emotional support along with increased access to community-based resources and services throughout the community, thereby also supporting local businesses and services within the community.

#### **Additional Fiscal Information**

This grant does not require any county matching funds. The total aggregate amount awarded to RUHS-PH is \$2,328,895. There is no impact to County General Funds. #### Contract History

On August 2, 2022, the Board of Supervisors approved Agenda Item 3.26 to approve Grant Agreement No. 21-11057 with CDPH for the Implementation of the CYSHCN Innovation Grant in the aggregate amount of \$1,279,922 for the period of performance of February 1, 2022, through June 30, 2025. This funding has been instrumental for RUHS-PH's MCAH Division in their efforts to support interventions that address the broader needs of CYSHCN, create more systems level change, and focus on a strengths-based resilience-building approach for CYSHCN and their families.

The request before the Board today is to authorize the Public Health Director to sign the Grant Agreement once it becomes available. Additionally, RUHS-PH is requesting approval for the Public Health Director to be charged with the responsibility of administering and implementing the CYSHN Program for RUHS-PH, including accepting additional funding from CDPH for the Program through June 30, 2035. This will allow RUHS-PH to streamline the approval process for future funding opportunities for the same Program.

NOTICE OF INTENT TO AWARD: GRANT AGREEMENT FOR THE CHILDREN AND YOUTH WITH SPECIAL HEALTH CARE NEEDS (CYSHCN) INNOVATION GRANTS, FISCAL YEARS 2025-2030.

The California Department of Public Health, Maternal, Child and Adolescent Health (CDPH/MCAH) Division intends to award your local health department CYSHCN Innovation Grant funding for administration of public health activities to improve systems that serve CYSHCN and their families.

To carry out the activities outlined in the Scope of Work (SOW) and Budget(s), during the period of July 1, 2025, through June 30, 2030, the CDPH/MCAH Division will reimburse expenditures up to the following amounts:

- Year 1 (July 1, 2025 June 30, 2026): \$ 465,779
- Year 2 (July 1, 2026 June 30, 2027): \$ 465,779
- Year 3 (July 1, 2027 June 30, 2028): \$ 465,779
- Year 4 (July 1, 2028 June 30, 2029): \$ 465,779
- Year 5 (July 1, 2029 June 30, 2030): \$ 465,779

Funds will be distributed through grant funding from the federal Title V Maternal and Child Health Services Block Grant. Awardees will be allocated the annual award amount listed above for each fiscal year (FY 25-26, FY 26-27, FY 27-28, FY 28-29, FY 29-30) as a one-time payment. Reimbursement of invoices is subject to compliance with all federal and state requirements pertaining to the program and adherence to all applicable regulations, policies, and procedures.



Please ensure that all necessary individuals within your Agency are notified of this intent. Additional documents will be forthcoming for review and to finalize the grant award.
