

BACKGROUND:

Summary

The City of Rancho Mirage approved the Second Amendment to the Law Enforcement Services Agreement (Second Amendment) for a modification of the level of service for FY21/22 through FY25-26 contract. This Second Amendment modifies the level of law enforcement service provided by the Sheriff's Office with the addition of one (1) Sheriff's Lieutenant. County Counsel has approved the Second Amendment as to form.

The FY24-25 estimated law enforcement service cost for the City of Rancho Mirage is \$12,981,300. Riverside Sheriff's Office staff has recommended budget adjustments that correspond with the additional contract position. Sheriff's Office staff has estimated this change will result in an estimated increase of \$108,900 in Contract Law Enforcement Revenue for FY24/25. The Sheriff's Office is recommending these budget adjustments now as it could not anticipate the additional expenditures to include them in its FY24/25 budget.

Impact on Residents and Businesses

This is a Second Amendment between the City of Rancho Mirage and the Sheriff's Office for law enforcement services, which the City of Rancho Mirage approved and executed on behalf of its citizens. All costs for this service will be fully recovered through the Sheriff's Office Board-approved rates.

Requests to Address Board on "Agenda" Items:

You may request to be heard on a published agenda item. Requests to be heard must be submitted to the Clerk of the Board before the scheduled meeting time.

Requests to Address Board on items that are "NOT" on the Agenda:

Notwithstanding any other provisions of these rules, member of the public shall have the right to address the Board during the mid-morning "Oral Communications" segment of the published agenda. Said purpose for address must pertain to issues which are under the direct jurisdiction of the Board of Supervisors. YOUR TIME WILL BE LIMITED TO THREE (3) MINUTES. The Board may limit the public input on any item, based on the number of people requesting to speak and the business of the Board.

Power Point Presentations/Printed Material:

Speakers who intend to conduct a formalized Power Point presentation or provide printed material must notify the Clerk of the Board's Office by 12 noon on the Monday preceding the Tuesday Board meeting, ensuring that the Clerk's Office has sufficient copies of all printed materials and at least one (1) copy of the Power Point CD. Copies of printed material given to the Clerk (by Monday noon deadline) will be provided to each Supervisor. If you have the need to use the overhead "Elmo" projector at the Board meeting, please ensure your material is clear and with proper contrast, notifying the Clerk well ahead of the meeting, of your intent to use the Elmo. Speakers are prohibited from bringing signs, placards, or posters into the hearing room.

Individual Speaker Limits:

Individual speakers are limited to a maximum of three (3) minutes. The Board may limit the public input on any item, based on the number of people requesting to speak and the business of the Board. Please step up to the podium when the Chair calls your name and begin speaking immediately. Pull the microphone to your mouth so that the Board, audience, and audio recording system hear you clearly. Once you start speaking, the "green" podium light will light. The "yellow" light will come on when you have one (1) minute remaining. When you have 30 seconds remaining, the "yellow" light will begin flash, indicating you must quickly wrap up your comments. Your time is up when the "red" light flashes. The Chair adheres to a strict three (3) minutes per speaker. Note: If you intend to give your time to a "Group/Organized Presentation", please state so clearly at the very bottom of the reverse side of this form.

Group/Organized Presentations:

Group/organized presentations with more than one (1) speaker will be limited to nine (9) minutes at the Chair's discretion. The organizer of the presentation will automatically receive the first three (3) minutes, with the remaining six (6) minutes relinquished by other speakers, as requested by them on a completed "Request to Speak" form, and clearly indicated at the front bottom of the form.

Addressing the Board & Acknowledgement by Chair:

The Chair will determine what order the speakers will address the Board and will call on all speakers in pairs. The first speaker should immediately step to the podium and begin addressing the Board. The second speaker should take up a position in one of the chamber aisles to quickly step up to the podium after the preceding speaker. This is to afford an efficient and timely Board meeting, giving all attendees the opportunity to make their case. Speakers are prohibited from making personal attacks, and/or using course, crude, profane or vulgar language while speaking to the Board members, staff, the public and/or meeting participants. Such behavior, at the discretion of the Board Chair may result in removal from the Board Chambers by Sheriff Deputies.

Dear current Riverside County Board of Supervisors,

Please review the written statements listed below prior to the consideration of agenda Item: 3.48 (Sheriff department position (Lieutenant) funded solely by City of Rancho Mirage Resident's).

During the City of Rancho Mirage April 3, 2025 Council meeting (agenda Item: 6C - Contracts) an amendment was approved by that unique body of officials, most were previously appointed and than elected to their current city council positions. There is still one appointed City Council members (Fromberg Edelstein) that has exceeded a reasonable amount of time in her role as an appointee for an elected city council position. It's reasonable to consider that the current Rancho Mirage City Council have and will continue to impose self serving political maneuvers to secure their own positions (status) at city residents expense.

It was stated within a city of Rancho Mirage staff report that because of systematic changes at the county level, cities are now required to independently fund their own dedicated Lieutenant(s). Current City Council members have a deep desire to protect themselves and their business Interests over the basic concept of providing good governance for residents of the once great city of Rancho Mirage. City officials (council) approved anticipated expenditures of \$100,300.00 for the remainder of the fiscal year an additional yearly expenditure of \$373,200.00 to secure a dedicated Riverside County Administrative Lieutenant position.

It's highly concerning that Riverside County staff report (agenda Item: 3.48 - form 11) clearly states that City of Rancho Mirage approved it's second contract amendment for a modification of the level of service for FY21/22 through FY25/26. That amendment provided ONE (1) ADDITION Sheriff's Lieutenant. But No

mention was made that Riverside County had eliminated the once provided role of a dedicated Lieutenant to the City of Rancho Mirage during a service contracted period.

It's also worth noting, that a new Riverside County Sheriff Lieutenant was assigned (first Introduction) to the City of Rancho Mirage at the very same April 3, 2025 City of Rancho Mirage Council meeting when a second contract amendment was approved to secure (finance) a dedicated Lieutenant for the city. That action was assigned under the city's consent calendar (contracts) which wouldn't dictate open public disclosure.

It's reasonable to consider that radical political maneuvers are being performed at City of Rancho Mirage Resident's expense. It appears that inconsistencies have been detected between City of Rancho Mirage staff report and Riverside County's staff report (form 11).

Please don't take any reprisal actions against my private property or person for reporting this true and accurate summary of concerns and opinions in regards to this topic of discussion.
