

**BACKGROUND/APPOINTEE INFORMATION:**

Supervisor Jose Medina recommends the appointment of Stephanie Virgen as the First District Alternate, to the Coachella Valley Association of Governments (CVAG) Executive Board and the Coachella Valley Conservation Commission. Ms. Virgen has her Master of Public Administration from California State University-San Bernardino, a Bachelor of Arts in Political Science from University of California Riverside, and an Associate of Arts degree from the Collage of the Desert in Policial Science.

Ms. Virgen has been a Council Member in the City of Coachella since November 2022, where she created the first Women's Leadership Conference, served on CVAG's Energy and Sustainability Committee and Energy Commission on behalf of the City of Coachella. She also served as a Planning Commissioner for the City of Coachella. Ms. Virgen is currently a Legislative Assistant for the County of Riverside, District Four Board of Supervisors. She works collectively with county departments and assists with policy around energy and community benefits, land development, and facilitates Fourth District events.
