BACKGROUND:

Summary 5 1 1

The Juan Bautista de Anza National Historic Trail retraces the route traveled by the Anza colonizing expedition during the years 1775–1776. Starting in Sinaloa and Sonora, New Spain (now in Mexico) and following existing Indigenous trails, Anza led over 240 colonists to San Francisco to establish a mission and presidio. The expedition was composed of colonists that included 30 soldiers, their wives, and more than 100 children, as well as Indigenous guides, vaqueros, muleteers, and servants, among others. The families reflected mostly the lower castes of colonial New Spain—a mix of Indigenous, African, and European heritage.

The historic trail connects Mexico to San Francisco and the 18th century to the 21st. The Anza Trail invites travelers to learn about the interweaving of the three elements of the Spanish plan for the colonization of its northern frontier: presidios (military forts), missions (religious centers), and pueblos (civilian towns) and makes connections to the current-day consequences of their historical actions. On June 27, 1776, the expedition families arrived in the area that is now San Francisco. Anza forged alliances with several Tribes along the route, but ultimately, Spanish colonization advanced a violent and devastating blow to the Tribal worlds as they existed.

Today, the Tribal communities whose lands Anza traveled through—Quechan, Ohlone, O'odham, Tongva, and many more—continue to thrive and pass on their traditions. The descendants of colonist Californio families also commemorate their heritage along the Anza Trail. The current 1,200-mile Juan Bautista de Anza National Historic Trail connects history, culture, and outdoor recreation from Nogales, Arizona, to the San Francisco Bay Area. Exploring the Anza Trail is far more than outdoor recreation. The sites along its corridor magnify intergenerational knowledge, complex histories, and vibrant, diverse cultural traditions that honor shared heritage and human experiences.

Through the Partnership Certification Agreement, the National Park Service and the Riverside County Regional Park and Open-Space District agree to work jointly on planning, interpreting, resource management, and other matters that are related to the Juan Bautista de Anza National Historic Trail along Santa Ana River Trail.

The Santa Ana River Trail segment referenced in Exhibit B: General location map and Detailed location map intersects the historic corridor. The trail segment parallels the site of the expedition's campsite #59 and includes an opportunity for a deeper understanding of and connection to the expedition through the interpretive panel/wayside located along the Santa Ana

River Trail at Marth McLean Anza Narrows Park. The proposed segment assists with continuity to existing and proposed recreational trail routes in adjacent jurisdictions. Through collaborative partnership and decision-making, a route for the continuity of the recreational retracement trail can be determined.

Impact on Residents and Businesses

Commitment to trail certification is a partnership formalized with a simple, legally non-binding agreement that says that the parties will work together toward the general mutual goals stated in the agreement. National Park Services, as the administering agency, will provide a certificate and trail logo designating the property as a national historic trail certified segment.

Partnership Certification Agreement

Between the National Park Service RIVERSIDE COUNTY REGIONAL PARK AND OPEN-SPACE DISTRICT Jurupa Valley, Riverside, California GENERAL

This agreement represents the Secretary of the Interior's certification of a partnership, under section 7(h) of the National Trails System Act, that the SANTA ANA RIVER TRAIL, managed by RIVERSIDE COUNTY REGIONAL PARK AND OPEN-SPACE DISTRICT, owned by RIVERSIDE COUNTY REGIONAL PARK AND OPEN-SPACE DISTRICT (RivCoParks) and COUNTY OF RIVERSIDE, and located in the City of Riverside along the Santa Ana River between Van Buren Boulevard and Rubidoux Avenue. The described portions of the Santa Ana River Trail meet the national historic trail criteria established by the National Trails System Act and any supplemental criteria prescribed by the Secretary of the Interior.

The National Park Service and the RivCoParks agree voluntarily to strive to achieve the highest level of visitor appreciation of trail resources, as provided for in the Comprehensive Management and Use Plan for the Juan Bautista de Anza National Historic Trail for "... the identification and protection of the historic route and its historic remnants and artifacts for public use and enjoyment." (National Trails System Act 16 U.S.C. – 1241 et seq. Section 3(a)(3)).

Through this agreement, the National Park Service and RivCoParks agree to work jointly on planning, interpreting, resource management, and other matters that related to the Juan Bautista de Anza National Historic Trail along SANTA ANA RIVER TRAIL and strive to meet the goals and objectives of the Comprehensive Management and Use Plan for the trail.

RivCoParks and COUNTY OF RIVERSIDE retain all legal rights to the property, and nothing in this agreement is to be construed as granting any legal authority to the National Park Service over the property or any action by RivCoParks and COUNTY OF RIVERSIDE.

The agreement may be canceled by either party at any time by providing written notice to the other party. The National Park Service agree, whenever possible, to identify issues or concerns to allow for resolution.

This agreement will remain in effect unless cancelled by either party, or until the ownership of the property is transferred to another entity.

TRAIL SEGMENT CERTIFICATION

I hereby agree to a partnership with the National Park Service for SANTA ANA RIVER TRAIL, a certified trail segment of the Juan Bautista de Anza National Historic Trail.

D. Legal and Policy Compliance

To achieve and retain official site certification, any use, development, or resource management activity at the site (such as historic restoration and rehabilitation, vegetation controls, exhibits, etc.) will require compliance with all applicable environmental and historic resource protection laws including the National Environmental Policy Act, Section 106 of the Historic Preservation Act, and others as required.

Section 5 (a) (15) of the National Trails System Act (16 U.S.C. 1241 et seq.) states that, for the Juan Bautista de Anza National Historic Trail, "Before acquiring any easement or entering into any cooperative agreement with a private landowner with respect to the trail, the Secretary shall notify the landowner of the potential liability, if any, for injury to the public resulting from physical conditions which may be on the landowner's land. The United States shall not be held liable by reason of such notice or failure to provide such notice to the landowner." The states of Arizona and California have statutes that can protect landowners from liability arising from recreational use of their lands by the public when no fees are charged.

The landowner remains responsible to the extent required by law for the potential liability, if any, for injury to the public resulting from physical conditions which may be on the landowner's land.

By entering into this certification agreement, the National Park Service, the Department of the Interior and the United States Government assume no liability for any injury to the public resulting from the physical conditions which may be present on the land.


