

BACKGROUND:

Summary

The Political Reform Act prohibits a public official from using his or her position to influence a government decision in which he or she has a financial interest. Government Code section 87300 requires local government agencies to adopt and promulgate a Conflict of Interest Code identifying officials and employees required to file statements of economic interest based on the positions they hold. A local government agency, as defined by Government Code section 82041, includes the Temecula Valley Unified School District.

Each even-numbered year, Government Code section 87306.5 requires local government agencies to review their Conflict of Interest Code, make appropriate revisions, if necessary, and submit an amended Conflict of Interest Code to the code reviewing body. Government Code section 82011(b) identifies the Board of Supervisors for the County of Riverside as the code reviewing body for a local government agency within its county.

The Temecula Valley Unified School District amended its Conflict of Interest Code on June 11, 2024, to add positions, revise disclosure categories and revise titles of existing positions that participate in making governmental decisions. The Governing Board for Temecula Valley Unified School District has adopted Resolution No. 2023-24/27, amending its Conflict of Interest Code. The Temecula Valley Unified School District has submitted its amended Conflict of Interest Code for approval by the Board of Supervisors as the code reviewing body.

This office has reviewed the Conflict of Interest Code of the Temecula Valley Unified School District and has found that it complies with statutory requirements. A complete copy of the Conflict of Interest Code of the Temecula Valley Unified School District is attached.

It is recommended that the Board of Supervisors approve the Conflict of Interest Code of the Temecula Valley Unified School District and direct the Clerk of the Board to notify the Temecula Valley Unified School District of the action taken.
