BACKGROUND:

On November 17, 2020, the Riverside County Board of Supervisors (Board) directed the Executive Office to implement an Unincorporated Communities Initiative (UCI). The UCI is a focused, ongoing, and coordinated effort to improve the infrastructure and services provided to the residents of unincorporated communities, with emphasis on Disadvantaged Unincorporated Communities (DUCs). The UCI receives authorized General Fund/Net County Cost (NCC) monies from the County during the annual budget and quarterly budget revision process.

On December 15, 2020, the Executive Office presented a proposed framework for planning and implementation of the UCI. With the support of the Board, the Executive Office established a team of staff and department heads to facilitate the UCI program. Through March 31, 2021, the Executive Office team held 15 community meetings and conducted online surveys to better understand community needs for services, infrastructure, and infrastructure maintenance. On May 25, 2021, the UCI Team presented the needs assessment to the Board.

On June 27, 2023, the Board adopted the FY23/24 Budget, which included the allocation of \$10,000,000 in NCC General Funds to the Unincorporated Communities Initiative. The \$10,000,000 was to be divided evenly between the five Supervisorial Districts for each Supervisor’s use within their unincorporated communities.

Based on the foundational work completed by the UCI Team and further analysis by this office, \$56,610 of the remaining available UCI funding for the Fourth District will be allocated to the following project:

- **Men’s Treatment Facility Improvements: \$56,610** to The Ranch Recovery Centers, Inc. to assist with the conversion of existing building space to medical offices at their facility located at 7885 Annadale Avenue, Desert Hot Springs, CA 92240.

Impact on Residents and Businesses

The Ranch Recovery Centers Inc. is converting existing building space (kitchen and dining room) to much needed medical offices at their facility located at 7885 Annadale Avenue, Desert Hot Springs, CA 92240. The Ranch Recovery Centers, Inc. medical staff has grown from one doctor and one nurse starting back in 2018, to 1 Medical Director, 1 Psychiatrist, 2 Physician Assistants, 1 Registered Nurse, 3 Licensed Vocational Nurses, and 4 Medical Assistants. The medical staff are currently scattered throughout their facilities and this project will bring all medical staff under one roof to better serve their patients.

The Ranch Recovery Centers, Inc. is a 501 (C) 3 organization, providing substance use treatment services to low- and no-income services to men, women and families since November of 1971.
