

BACKGROUND:

Summary

The First District is requesting to allocate Cannabis DA Funds to assist in the purchase of two Combi tools for use by the Highgrove Fire Station. A Combi tool is a versatile tool that combines several functions into one device, allowing firefighters to perform multiple tasks with a single piece of equipment. These tools are crucial for extrication, cutting, and spreading in various rescue scenarios, particularly in vehicle extrication and limited-space operations.

Based on analysis by this office, \$20,000 is available in FY 24/25 First District Cannabis DA funding and shall be allocated to the Highgrove Fire Station for the purchase of two Combi tools to be used in the Highgrove community.
